Brent Hall is an attorney in the Office of Legal Counsel of the Confederated Tribes of the Umatilla Indian Reservation. His current practice focuses on treaty rights, environmental, and natural resource matters. Brent represents the Umatilla Tribes in federal, state, and tribal courts in cases involving the exercise and protection of treaty reserved rights and resources including tribal First Foods. He has also negotiated and implemented agreements with federal and state agencies related to Columbia River Basin hydro system operations, Indian and non-Indian harvest, hatchery operations, and habitat restoration.

Peter Dygert is Chief of the Anadromous Harvest Management Branch in the Sustainable Fisheries Division of the National Oceanic and Atmospheric Administration (NOAA) Fisheries' West Coast Regional Office. Peter has worked for NOAA since 1991. His primary responsibility has been evaluating the effects of harvest actions on Endangered Species Act (ESA) listed species. He is directly involved with the management of west coast salmon fisheries and participates in processes related to the Pacific Salmon Treaty, Pacific Fishery Management Council (PFMC), the Columbia River, and the Puget Sound.

Stuart Ellis is a Fisheries Scientist in the Fisheries Management Department of the Columbia River Inter-Tribal Fish Commission (CRITFC). He has worked for CRITFC since 2000, providing support for the four treaty Tribes in managing their mainstem fisheries and in the PFMC and *U.S. v. Oregon* forums. He serves on the *U.S. v. Oregon* Technical Advisory Committee. Previously, he supported the Washington coastal Tribes' management of ocean salmon and groundfish fisheries while working for the Northwest Indian Fisheries Commission.

Guy Norman is the Washington Department of Fish and Wildlife's (WDFW) Regional Director for Southwest Washington. He is the policy lead for fishery, habitat, and wildlife issues. Guy represents WDFW on the Policy Committee for *U.S. v. Oregon*, the Columbia River (fishery) Compact, the Federal Columbia River Power System Biological Opinion Regional Implementation Oversight Group, and is a Board member for the Lower Columbia River Estuary Partnership. Guy began with WDFW as a fishery biologist in 1977.

Rob Jones is the Chief of the Anadromous Production and Inland Fisheries Branch in the Sustainable Fisheries Division of NOAA Fisheries' West Coast Regional Office. In this capacity he supervises ESA reviews of Hatchery Genetic Management Plans and Fishery Plans for Pacific salmon and steelhead. Rob has been with NOAA Fisheries since 1986.

Becky Johnson is Director of the Production Division for the Nez Perce Tribe's Department of Fisheries Resources Management. She has been involved with hatchery production of salmon and steelhead in the Columbia River Basin for the past 20 years in the pursuit of multiple objectives including: preventing extirpation, rebuilding natural runs, and providing fish for harvest. She has been involved in the planning, development, construction, and operation of several hatchery programs including the Nez Perce Tribal Hatchery and the Snake River fall Chinook supplementation program. As a representative of the Nez Perce Tribe, Becky also works with the Oregon Department of Fish and Wildlife, Idaho Department of Fish and Game, Washington Department of Fish and Wildlife, U.S. Fish and Wildlife Service, and the Confederated Tribes of the Umatilla Indian Reservation to co-manage the production of 30 million hatchery fish in the Snake Basin annually. Becky is also a member of the *U.S. vs. Oregon* Production Advisory Committee, which oversees a large portion of the hatchery production in the Columbia River Basin.

Paul Kline is currently the Assistant Chief of Fisheries for Idaho Department of Fish and Game. His broad responsibilities include coordination of the Fisheries Management, Research, and Artificial Production programs. Paul has held a variety of positions with the Department since he joined in 1992 including oversight of programs such as the Snake River sockeye salmon captive broodstock program and the Salmon River spring Chinook captive rearing program as well as evaluating hatchery mitigation efforts for Snake River salmon and steelhead. He has worked on the Hatchery and Genetic Management Plans for ESA compliance and participated in the Northwest Power and Conservation Council's Artificial Production Review and Evaluation. Paul has been a member of the Columbia River Hatchery Scientific Review Group since 2006.

Ritchie Graves is Chief of the Columbia Hydropower Branch for NOAA Fisheries' West Coast Regional Office. From 1997 to 2006, he represented NOAA Fisheries as a technical expert on a large number of hydropower relicensing efforts including the five hydroelectric projects in the mid-Columbia reach owned by the Chelan, Grant, and Douglas County Public Utility Districts and the Hells Canyon Complex owned by Idaho Power Company.
