

Executive Order 13158

- Develop and implement a scientifically based, comprehensive national system of MPAs representing diverse U.S. marine ecosystems, and the Nation's natural and cultural resources
- Improve MPA coordination, stewardship and effectiveness
- Support, not interfere with, agencies' independent exercise of their own existing authorities.







- Three drafts developed for public comment









Role of MPA FAC in Developing Framework

Why Update?

- Reflect implementation experience since November 2008
- Incorporate MPA Federal Advisory Committee recommendations
- Reflect changing ocean policy, science and management context

Major Milestones in National System Development

- Nov 2008 National System Framework completed
- April 2009 First 225 "charter" sites accepted into system
- June 2009 First meeting of MPA System partners
- Today 437 sites in National System

What's the Same?

- National System goals and objectives
- MPA definitions
- Nomination process





National System Goals



What's Different?

- Shortened and streamlined language
- Separated sections about existing and new MPAs to make it clearer which is being discussed
- Focused more on functions of national system, rather than operational mechanics
- More flexible approach to engaging in MPA activities in regions
- Broader view of cultural resources
- Greater recognition of tribally managed areas as potential members of the National System

Framework Review Process

- Federal Agency Review (through mid-June)
- Public review (90 days; late summer 2014)
 - FAC members will also have an opportunity to review
- Revised/Final draft (late 2014)
