Dear Mr. Engberg:

This is a final response to your request for records that you made to the Bonneville Power Administration (BPA), under the Freedom of Information Act (FOIA), 5 U.S.C. 552.

You have requested the following:

Purchase Orders or itemized payment amounts for orders of the following BPA Catalog ID numbers: 606723, 606220, 606205, 606304, 646475, 607375. From January 1, 2009 to December 31, 2011.

Response:

BPA has pulled an itemized report on orders of BPA Catalog ID numbers: 606723, 606220, 606205, 606304, 646475, 607375 for the period from January 1, 2009 to December 31, 2011, with some information withheld under Exemption 4.

Under Exemption 4 of FOIA, information may be exempt from disclosure if it is "commercial" in nature, is "obtained [by BPA] from a person (the vendors)," and is "privileged or confidential." Here, there is no question that the redacted information in the contract is commercial in nature and that its release would likely cause the noted vendors, substantial competitive harm.

Pursuant to 10 CFR 1004.8, if you are dissatisfied with this determination, or the adequacy of the search, you may appeal in writing within 30 calendar days of receipt of a final response letter. The appeal should be made to the Director, Office of Hearings and Appeals, HG-1, Department of Energy, 1000 Independence Avenue, SW, Washington, DC 20585-1615. The written appeal, including the envelope, must clearly indicate that a FOIA Appeal is being made.
