

This is in response to the request for information that you sent to the Department of Energy (DOE) under the Freedom of Information Act (FOIA), 5 U.S.C. 552. You asked for the contract agreement for Administrative Professional Supplemental Labor Services, under contract number DGP-7, currently in effect between the Bonneville Power Administration and Ciber Inc.

Any documents that may exist at the DOE that are responsive to the request are under the jurisdiction of the Bonneville Power Administration (BPA) of the Department. I have sent the request to Ms. Christina Munro, the FOIA Officer at that location, to conduct a search of its files and provide you a response about the releasability of any responsive documents located.

Your letter does not state a willingness to pay fees associated with the processing of the request.
