Attempt 1.a.:

The previous TCP contract has been closed since August 1, 2010 and cannot be reopened. BPA will have to issue a new intergovernmental contract for the TCP work. I'm planning on drafting a new statement of work regarding the TCP study early next week for the Yakama Nation to provide a cost estimate for completing the work. Regarding the 2008 TCP report, BPA's funding was through the direct funding agreement between the Corps and BPA for projects related to the Federal Columbia River Power System. Funds were transferred from BPA to the Corps for the Corps to use for various purposes including contracting for cultural resource related tasks. The deliverable under that funding was provided to the Corps and, as we have acknowledged, was unfortunately not provided to BPA either in 2008 or in 2010. We would appreciate if you could send us a copy - thank you for the offer.

With regard to the survey areas, due to the ongoing concerns regarding safety, the probable lack of access to many of the unsurveyed areas in the last 14 miles of the project, and the imperative of moving forward on the TCP study as quickly as possible BPA believes that it would be better to pursue contracting for the remaining surveys with a private firm. However, BPA would encourage the contractor to subcontract with the YN for participation on the survey crew if agreeable to the YN. ~~We will be willing to modify the contract for subsurface testing of the structure near the access road where the field scanner was discovered in mile 11 as well as conducting the damage assessment for placing the five poles on the site. <- thoughts on this? I had agreed to these in previous conversations. [I'm not sure of the implications of that - sounds fine to me]~~

Good Morning,

I'm following up on a couple of outstanding matters that I think can be resolved relatively quickly.

First, I understand from our conversations over the past couple of days that BPA is willing to re-open the TCP Contract with the Yakama Nation concerning the Bid Eddy-Knight Project provided that the Yakama Nation staff agree to expedite their work on updating the Yakama Nation's TCP Report. So everyone is on the same page, on February 1, 2012 Mr. Meninick requested this contract be re-opened to permit supplementation. We also made numerous verbal requests in that regard to Mr. Kevin Cannell; requests which were never formally granted or denied. In order to prevent further delay and additional time constraints on our staff, I think it's imperative that we resolve this issue as soon as possible. Towards that end, please let us know what time frame BPA would like in order to complete supplementation of the TCP Report for this project. Also, regarding the 2008 Yakama Nation TCP Report that was partially funded by the BPA, I was first notified during yesterday's conversation that BPA contends it never received this report. I find it odd that BPA would fund the 2008 TCP study in this area (along with the Army Corps of Engineers) and no one from BPA has ever received the TCP Report when it was finalized several years ago. Nevertheless, if you maintain that your agency has never received this, I will work to get you a copy of that report now.

Second, we've spoken over the past several weeks about the safety protocols that BPA is working with us to implement to ensure that landowners don't open fire again on our Cultural Resources Program ("CRP") personnel while they're performing contract work for the BPA on this Project. I understand that the protocols are near finalization. Ms. Grimm also told me that not all of the suggested edits made by our CRP staff were accepted by BPA. While the next draft protocols are being finalized by BPA, would you be willing to share with us the edits you made to the draft provided by CRP personnel? This will help expedite my work in seeking to get the Chairman's moratorium lifted. If for whatever reason, the Chairman finds the protocols are still inadequate, I would like to work sooner rather than later to get mutually acceptable safety protocols in place so this aspect of the work on the Big Eddy-Knight Project can move forward. Our CRP has experienced significant problems stemming not only from the shooting incident, but also from having the necessary moratorium in place and not getting the safety protocols finalized so the CRP can continue with their work. They had allocated resources and time to get the work under the survey contract complete over the last couple of months, and not having the ability to do work on this has created financial hardship and other staffing problems for the CRP.

Finally, I look forward to receiving the action items list the ACHP requested from BPA at the conclusion of our phone conference yesterday. I believe getting the survey report and BPA's determination of eligibility for the archaeological site boundary expansion for the 45KL77 site pursuant to Stipulation I of the Programmatic Agreement, in addition to re-opening the TCP Contract to supplement Gideon Cauffman's initial TCP Report are essential steps to moving forward with the ongoing government-to-government consultation process required under federal law, and to ensure that the Programmatic Agreement relative to this project is honored.
