Dear MS. Munro:

The following is a formal request for information under the Freedom of Information Act. I have repeatedly, for more than a year, requested this same information (via e-mail and verbally) from other BPA management personnel. I have, for the first time, just been informed of your office and procedure.

I am Art Marshall. I make this request in conjunction with my duties and responsibilities as the Oregon Commission for the Blind (OCB), Business Enterprise Program Director.

OCB requests complete copies of the original ARAMARK food service contract including all exhibits and all renewals thereof connected to the Cafeteria in the Bonneville Power Head quarter building located at 905 NE 11<sup>th</sup> Ave. Portland Oregon, in the Lloyd Center.

OCB does not have access to the dates but believes the original contract dates back eighteen years ago or more. We believe there have been at least three renewals.

OCB makes this request in its capacity as the State licensed Agency of the federal Randolph Sheppard Act Program. The information request is intended to assist OCB in acquiring the contract (under the provisions of the Randolph Sheppard Act) for operating the 905 NE 11<sup>th</sup> Portland Oregon, BPA building cafeteria.

OCB, in the interest of the public, requests a waiver of any associated fees however, OCB will pay reasonable and appropriate fees if a waiver is not granted.

Please notify us immediately if we have made any errors or omissions in this request. We will correct them immediately. Please contact me if you have any questions.

OCB will appreciate any help you can provide in expediting this request. OCB has been seeking this information for more than a year from BPA management not knowing and not having been

informed that a State agency, licensed under the Federal Randolph Sheppard Act, would have to complete this formal FOIA request.
