Dear Ms. Drummond:

This is the final response to your request for information that you made to the Bonneville Power Administration (BPA) under the Freedom of Information Act (FOIA), 5 USC § 552.

#### **You have requested the following:**

All documents describing the process for submitting, processing, and making decisions on funding pursuant to the Friends of the Columbia Gorge, Inc., settlement agreement. The County also requests all documents (including e-mail correspondence) related to the development of this process.

#### **Response:**

The responsive documents are provided on the enclosed CD. Exemption 5 and Exemption 6 have been applied to the responsive documents.

Exemption 5 protects from mandatory disclosure "inter-agency or intra-agency memorandums or letters that would not be available by law to a party other than an agency in litigation with the agency. . ." Exemption 5 incorporates the deliberative process privilege which protects advice, recommendations, and opinions that are part of the process by which agency decisions and policies are formulated.

The documents withheld under Exemption 5 are pre-decisional documents that discuss several options for the data and other information used in the draft environmental impact statement. Draft documents, by their very nature, are pre-decisional because they are prepared prior to the undertaking of any final action by the agency. Draft documents are deliberative because they are part of the deliberative process by which that agency action was considered and taken. They reflect only the tentative view of their authors, views that might be altered or rejected upon further deliberation either by the authors or by their superiors. The withheld draft documents do not represent final agency decisions on the final document. The documents being withheld in their entirety are being withheld because they express opinions that fall within the deliberative process privilege.

BPA asserts Exemption 6 for information which could reasonably be expected to constitute an unwarranted invasion of personal privacy if disclosed. The withheld information consists of the names and personal contact information (address, email, and/or phone numbers) of individual citizens who have expressed an interest in this Project, as well as the personal cell phone numbers and email addresses of various individuals working on this Project. Release of this information could subject these individuals to unwanted intrusions of privacy. There is no public interest in the disclosure of this information because it does not shed any light on how BPA has performed its statutory duties.

Pursuant to 10 CFR 1004.8, if you are dissatisfied with this determination, or the adequacy of the search, you may appeal in writing within 30 calendar days of receipt of a final response letter. The appeal should be made to the Director, Office of Hearings and Appeals, HG-I, Department of Energy, 1000 Independence Avenue, SW, Washington, DC 20585-1615. The written appeal, including the envelope, must clearly indicate that a FOIA Appeal is being made.

**Settlement Agreement for Big Eddy-Knight  
with the Friends of the Columbia Gorge**

*November 2011*

**What this is**

The Bonneville Power Administration and Friends of the Columbia Gorge have reached an agreement on measures to protect and enhance scenic and natural resources in the Columbia River Gorge National Scenic Area.

These measures will help address concerns about potential alterations of National Scenic Area landscapes from BPA's Big Eddy-Knight transmission line project, which is currently under construction. Approximately 7 miles of this new 28-mile 500-kilovolt high-voltage power line will be located in the National Scenic Area. The agreement will help us work together to preserve the area's scenic qualities.

Under the agreement, BPA will work with Friends to support a wide variety of possible natural and scenic resource protection measures within or near the National Scenic Area. Examples include the removal of physical structures; restoration of disturbed areas; undergrounding of low-voltage electric distribution lines, telephone lines, fiber optic lines, or other equipment owned by non-federal utilities; and acquisition of land by a suitable land trust or appropriate state or federal land managing agency for land preservation purposes.

BPA will make about \$1.78 million available to third parties to fund these measures. BPA will review and approve all funding requests that comply with the agreement and will coordinate proposed measures within the National Scenic Area with the Columbia River Gorge Commission and the U.S. Forest Service.

BPA started construction of the project in September. At its peak, the line will create approximately 100 construction jobs. BPA expects to complete and energize the line in February 2013. It will help BPA accommodate requests for transmission service, integrate renewable energy to the grid and increase overall system capacity. The increase in capacity will help the system deliver energy into the Portland, Ore., area, which is becoming increasingly challenging.

A sum of \$1,787,500 will be made available to help address concerns about potential project effects on visual quality in the Columbia River Gorge National Scenic Area. The funds can be used for any of the following purposes with joint approval by BPA and the Friends:

- Removal of discordant features within or adjacent to the National Scenic Area;
- Undergrounding of low-voltage lines (owned by local public utilities); and,
- Acquisition of Scenic Area lands administered by an approved land trust or willing state or federal agency.

The use of the funds will be carefully coordinated with the U.S. Forest Service and the Gorge Commission for maximum benefit and alignment with the Management Plan for the National Scenic Area. In addition, as part of the agreement, the Friends will agree that these efforts will satisfy their concerns, and that they will not challenge BPA's NEPA process or the U.S.D.A. Forest Service's Consistency Review process for the BEK project.

## Key messages

- Although BPA has made great efforts to lessen the visual effect of the BEK project, we acknowledge that the approximately seven-mile-long portion of the project located in the National Scenic Area will be in an area with heightened visual sensitivity.
- Recent conversations with the Friends have helped highlight this sensitivity and the reasonableness of taking additional steps to remove discordant features and otherwise help promote visual quality in this area.
- While the agreement is with the Friends, they will have no direct control over, nor keep for their own use, any of the money; and funds will be strictly for visual improvements.
- The specific activities to be funded have not yet been identified, but we fully expect that they will provide lasting benefit to the many users of the Columbia River Gorge.

## Background

In June 2009, BPA began environmental review of its proposed BEK project, which is a new 28-mile-long 500-kV transmission line extending from BPA's existing Big Eddy Substation in The Dalles, Oregon to a new BPA substation (Knight Substation) located about four miles northwest of Goldendale, Washington. Throughout this review process, the Friends expressed concerns about several aspects of the proposed project, including the effect of BPA's planned BEK project on the visual quality of the National Scenic Area. In September 2011, Friends submitted a settlement proposal to BPA to address their concerns. Given the Friend's role as an advocate for the National Scenic Area and their interest in protecting its visual quality, BPA agreed to discuss options for addressing their concerns.

After nearly two months of discussions, we signed a settlement agreement. The settlement amount is within the \$2 million approved by the CAB for the BE-K project.

## Questions and answers

### **1. How will funding decisions be made?**

The Settlement provides that the Friends will propose projects among the three categories discussed above. Both the Friends and BPA would have veto power over the choices, plus BPA would coordinate with the Gorge Commission and the Forest Service to ensure that projects would be consistent with their needs and the Scenic Area Management Plan. If, for example, a property acquisition is proposed, BPA, in consultation with the Commission and Forest Service, would select the agency or land trust to do the transaction.

**3. Will the Friends have any control over the Settlement funds?**

No. No payments will be made to the Friends. Their role will be to propose projects that will be then funded by BPA. One area of confusion can be projects that involve land acquisitions. BPA will consider such proposals, and if accepted, use only a land trust approved by us. It is important to note, however, that the Friends of the Columbia Gorge Land Trust is eligible for such funding, but that this Trust is independent of the Friends themselves (though there are some board members that serve on both the Trust and the Friends' governing boards.
