Dear Ms. Munro:

I am an attorney and legal representative of PáTu Wind Farm, LLC (PáTu), writing on behalf of PáTu to lodge a request with the Bonneville Power Administration (BPA), pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and implementing regulations thereto contained in Title 10, Code of Federal Regulations, Part 1004. I understand that you are BPA's FOIA compliance officer, and request that you please forward this request to the appropriate officials if you are not the correct recipient of FOIA requests.

PáTu requests that BPA provide the documents described as follows:

All documents within BPA's possession regarding BPA Technology Innovation Project No. 88 (TIP 88). This project was a Telemetry Demonstration Project. Other entities involved in this project may have included the Oregon Department of Energy, Portland General Electric Company, Ecofys US, Community Renewable Energy Association, Factory IQ, and three Demonstration Hosts, including PáTu.

This request includes all correspondence, contracts, memoranda or letters of understanding, e-mails and attachments thereto, as well as any other documents of any type, including those available only in electronic format.

PáTu expects that this information would be located with officials at BPA's office of Technological Innovation, and/or with the BPA personnel involved in the project. The individuals who may have been involved in the project at BPA included James Hall, Sarah Sundborg, and Paul Fiedler. PáTu believes the project was initiated in September 2009 and concluded in June 2010, but requests all available documents up to the date of

the response to this request.

PáTu understands that there may be some documents falling within the scope of this request that may be subject to a non-disclosure or other form of confidentiality agreement protecting proprietary information of Demonstration Hosts. PáTu was one of three Demonstration Hosts in BPA's TIP 88, and, for purposes of this FOIA request only, consents to release of all proprietary information specific to the PáTu project.

PáTu is a private limited liability company that makes this request for use in the company's business.

PáTu consents to payment for charges incurred by BPA in responding to this request up to a limit of \$500.
