Thank you for your request for records that you made to the Bonneville Power Administration (BPA) under the Freedom of Information Act (FOIA), 5 U.S.C. 552. Your request was received in this office on Thursday, July 12, 2012, and has been assigned a control number, BPA-2012-01627-F. You have requested the following:

Emails sent to attorney Cassandra Brown between October 2011 - December 2011 asking for phone records in 2008.

We reviewed your request and determined that it addresses all of the criteria of a proper request under the FOIA, DOE, and BPA regulation that implements the FOIA at Title 10, Code of Federal Regulations, Part 1004. However, in a phone conversation on July 12, 2012, you clarified that you were looking for one email that you had sent to Ms. Brown in which you asked for phone records from 2008. And that the email was dated between October 2011 - December 2011.
