Pennwalt Substation, 6400 NW Front Avenue, Portland, OR**

Dear Ms. Munro:

This firm represents Legacy Site Services, LLC ("LSS"), agent for Arkema Inc. (formerly known as Atofina Chemicals, Inc.). The Bonneville Power Administration ("BPA") historically operated an electrical substation at Arkema's former chlor-alkali facility, located at 6400 NW Front Avenue, Portland, Oregon. This substation was commonly referred to as the Pennwalt Substation. It appears that the BPA operated the Pennwalt Substation from 1982 until its decommissioning in 2002.

On behalf of LSS, and pursuant to the Freedom of Information Act, I hereby request the following public records:

1. Any power sales contracts (including Power Sales Contract No. 95MS-94856) between the BPA and Atofina Chemicals, Inc. or any predecessor to Atofina Chemical, Inc. (including Elf Atochem, Elf Aquitaine, and Pennwalt Corporation) relating to the Pennwalt Substation;
2. Any easements or releases of easements relating to the Pennwalt Substation;
3. Any leases between the BPA and Atofina Chemicals, Inc. or any predecessor to Atofina Chemical, Inc. (including Elf Atochem, Elf Aquitaine, and Pennwalt Corporation) relating to the Pennwalt Substation;


