**I request a waiver or reduction of fees because the disclosure is "likely to contribute" to an understanding of government operations or activities as explained below:**

*It will help the group determine how IJPA operates and arrives at decisions.*

**I request a waiver or reduction of fees because an understanding by the general public of the subject is likely to result from disclosure, taking into account my ability and intent to disseminate the information to the public in a form that can further understanding of the subject matter as explained below:**

*This information will be shared at various meetings with other homeowners and via our various websites.*

**I request a waiver or reduction of fees because the disclosure is likely to contribute "significantly" to public understanding of government operations or activities as explained below:**

*It will help our group and other homeowners to determine how BPA operates and arrives at*

*Disclosure of this information will serve the public interest and I am capable of disseminating the information to interested members of the public in a form and context that can further the public understanding of an important issue in public policy.*

**I request a waiver or reduction of fees because the disclosure is likely to contribute "significantly" to public understanding of government operations or activities as explained below:**

*Disclosure of the information is likely contribute significantly to the public understanding of the operation and activities of Bonneville Power Administration in its efforts to include interested parties in an effort to avoid protracted litigation.*

**I believe a compelling need exists** to warrant expedited processing because there is an **urgency** to inform the public concerning actual or alleged Federal Government activity exists as described below:

*This is an urgent matter as the Bonneville Administrator is presently contemplating execution of a product of the mediation process, i.e., the residential exchange program settlement agreement. The individuals who participated in the mediation leading to the draft settlement agreement have, to the best of my knowledge, not been disclosed to the public even though the issues that they addressed are of the utmost importance. Although I am not employed by a news organization, I intend to widely disseminate this information to interested members of the public in the Pacific Northwest, including but not limited to individuals who are members of federally recognized tribes in the Columbia Snake River basin.*
