Dear Mr. Clements:

This is an interim response to the request for information that you sent to the Department of Energy (DOE) under the Freedom of Information Act (FOIA), 5 U.S.C. 552. You asked for all lists of media contacts to whom the DOE sends news releases or calls on release of news or information. You asked for all lists compiled on the national, state, and site levels for print, radio, television, and internet media that include company name, reporter or company contact name, address, e-mail address, and telephone numbers.

Searches for responsive records will be conducted of the files of the Office of Public Affairs at Headquarters and the DOE field locations. Upon completion of the searches and the review of any records located, you will be provided a response.

In your letter, you requested a waiver of all fees associated with the processing of the request. For purposes of assessment of fees, you have been categorized under the DOE regulation that implements the FOIA at Title 10, Code of Federal Regulations, Section 1004.9(b)(4), as an "other" requester. In this category, you are entitled to two free hours of search time and 100 pages at no cost.

At this time, duplication fees for the request are not expected to exceed \$15.00, the minimum amount at which the DOE assesses fees. If fees exceed that amount, a determination will be made about your request for a fee waiver.
