Northeast Multispecies Common Pool Vessels

Increase in Trip Limits for Georges Bank Cod and Southern New England/Mid Atlantic Yellowtail Flounder

Effective Date: March 8, 2012, through April 30, 2012

Effective immediately, the trip limits for Georges Bank (GB) cod and Southern New England (SNE)/Mid-Atlantic (MA) yellowtail flounder are increased for vessels fishing in the common pool fishery under a Northeast (NE) multispecies day-at-sea (DAS) or Handgear B (HB) permit.

Frequently Asked Questions		
Why is this action being taken?	We make changes to the trip limits to prevent the underharvest or overharvest of common pool sub-annual catch limits (sub-ACLs).	
How much of the quota has been caught of these stocks?	As of February 25, 2011, 58.5 % of the GB cod and 1.2 % of the SNE/MA yellowtail flounder has been caught.	
What happens if the quota is exceeded?	Accountability measures would be put in place for fishing year (FY) 2012, beginning May 1, 2012. Exceeding the quota could result in differential DAS counting in FY 2012.	
Is there a chance that the trip limits will go back down?	If a sub-ACL is projected to be exceeded by the end of FY 2011, in-season adjustments to decrease the trip limit would be considered. The rates of harvest of all NE multispecies stocks are updated weekly on the internet at <u>http://www.nero.noaa.gov</u> .
