SUMMER FLOUNDER, SCUP, AND BLACK SEA BASS RECREATIONAL FISHERY SMALL ENTITY COMPLIANCE GUIDE 2012 RECREATIONAL HARVEST MEASURES

Effective date: Friday, May 18, 2012

We have approved the final 2012 minimum fish size, angler possession limits, and fishing season rules for the summer flounder (fluke), scup (porgies), and black sea bass (sea bass) recreational fisheries. States have already put rules in place for the season.

This rule implements the Mid-Atlantic Fishery Management Council's recommended start date for the recreational black sea bass fishery of May 19, 2012. This rule also implements conservation equivalency for the summer flounder fishery, and a year-round scup season.

Please keep in mind that if the Federal minimum size, possession limit, and/or season differ from the regulations for the state in which you will be landing, <u>you must follow the more restrictive regulations</u>.

See the tables below for information on what size fish you may keep, how many fish you may keep per day, and the days and months fishing is allowed.
