Reference: Order No. 1000 Interregional Compliance Filing

Dear Mr. Harward:

On March 3, 2016, Southwest Power Pool, Inc. (SPP) submitted revisions to section IV.6 of Attachment O of the SPP Open Access Transmission Tariff, in compliance with the Commission's order issued on February 2, 2016, as it relates to the SPP and Southeastern Regional Transmission Planning Group pair of neighboring transmission planning regions.¹ The February 2, 2016 order addressed the parties' compliance with the interregional transmission coordination and cost allocation requirements of Order No. 1000.² Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – Central, under 18 C.F.R. § 375.307, the submittals in the above referenced docket is accepted for filing, effective January 1, 2015³ and February 1, 2015,⁴ as requested.

Under 18 C.F.R. § 385.210, interventions are timely if made within the time prescribed by the Secretary. Under 18 C.F.R. § 385.214, the filing of a timely motion to intervene makes the movant party to the proceeding, if no answer in opposition is filed within fifteen days. The filing of a timely notice of intervention makes a State Commission a party to the proceeding. None was filed.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against any of the applicant(s).

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
