# **Northeast Multispecies Fishery**

Changes to Haddock Annual Catch Limits Effective September 14, 2011

The Gulf of Maine (GOM) and Georges Bank (GB) haddock Annual Catch Limits (ACLs) for the Northeast multispecies fishery have changed. Framework Adjustment 46 (Framework 46) to the Northeast (NE) Multispecies Fishery Management Plan (FMP) has increased the haddock incidental catch cap allocated to the Atlantic herring fishery, reducing the portion of these ACLs available to the commercial NE multispecies fishery. The adjusted fishing year (FY) 2011 sub-ACLs available to the common pool and sectors, and sector Annual Catch Entitlements (ACEs) are in the tables that follow.

### When are the measures in this letter effective?

Unless otherwise indicated, these measures are effective on September 14, 2011.

#### Are there other details that you have not described in this letter?

We have summarized only the measures that are essential to your day-to-day fishing operations for the remainder of fishing year 2011. Does Framework 46 change the FY 2011 sector GOM and GB haddock ACEs?

Yes, Framework 46 increased the sub-ACL allocated to the Atlantic herring fishery to 1% of the GOM haddock Acceptable Biological Catch (ABC) and 1% of the GB haddock ABC (up from 0.2% GOM and GB haddock combined). This reduced the amount of the haddock ACLs available to be divided between sectors and the Common Pool. New sector ACEs are in Table 1.

Does Framework 46 change the FY 2011 sector Eastern GB haddock ACEs?

No. A sector's Eastern GB haddock ACE is determined by the amount of Eastern GB haddock allocated through the U.S./Canada Understanding. The amount of Eastern GB haddock available to the NE multispecies commercial fishery (sectors and Common Pool) has not changed.

Have the FY 2011 Common Pool GOM and GB haddock sub-ACLs changed?

Yes. Framework 46 increased the sub-ACL allocated to the herring fishery, which reduced the amount of the haddock ACLs available to sectors and the Common Pool. New Common Pool sub-ACLs are in Table 1.



# Have the sub-ACLs for other NE multispecies stocks changed?

No. The sub-ACLs for stocks other than haddock published for sectors and the common pool in the adjustment rule published June 15, 2011, remain the same.
