SMALL ENTITY COMPLIANCE GUIDE

Dear Sea Scallop Permit Holder:

These attached sea scallop information sheets have been issued to summarize scallop regulations, scallop management programs, and 2007 scallop harvest specifications. There are eight information sheets that address the following aspects of scallop fishery management: General Category Scallop Permits, General Category Scallop Exemption Area Program, General Category Access Area Program, Limited Access Scallop Permits, Limited Access Access Area Program, Scallop Observer Program, Scallop Gear Requirements, and Gear Stowage Requirements.

The table of contents on the following page provides additional detail on each information sheet. Possession Limit Clarification: There has been confusion regarding the possession limit for general category scallop vessels. The following requirements pertain to all general category scallop vessels:

- General category 1B scallop vessels are prohibited from possessing or landing per trip more than 400 lb of shucked, or 50 bu of in-shell scallops;
- General category 1B scallop vessels may not fish for, possess, or land scallops on more than one trip per calendar day; and
- If using plastic baskets to approximate the possession limit, vessel operators must be aware these baskets may hold more than one U.S. bu of in-shell scallops. Vessel operators must be familiar with the volume of the baskets they are using. The volume of the basket is likely printed on the basket or can be determined by the distributor, dealer, or manufacturer, if operators are unsure of the volume. Ultimately, the vessel operator must ensure that the volume of in-shell scallops on board the vessel does not exceed 50 U.S. bu. One U.S. bu is the equivalent of 35.24 liters (L).
