### SMALL ENTITY COMPLIANCE GUIDE

Dear Limited Access Monkfish Permit Holder:

This letter is to inform you of a final rule implementing new target total allowable catch (TAC) levels for the 2004 monkfish fishery, and adjustments to days-at-sea (DAS) and trip limits for limited access monkfish vessels (Categories A, B, C, and D) fishing in the Southern Fishery Management Area (SFMA) for the 2004 fishing year (FY). These target TACs, trip limits, and DAS restrictions are based upon methods established in Framework Adjustment 2 to the Monkfish Fishery Management Plan (FMP), which became effective on May 1, 2003. Although FY 2004 begins on May 1, 2004, these regulations are not effective until **May 7, 2004**. Therefore, the trip limits in effect for FY 2003 will remain in place until the new trip limits are effective.

## EFFECTIVE MAY 7, 2004, THROUGH APRIL 30, 2005

- The target monkfish TACs for FY 2004 are 16,968 mt for the Northern Fishery Management Area (NFMA), and 6,772 mt for the SFMA.
- The trip limits for vessels fishing in the SFMA are reduced to 550 lb tail weight per monkfish DAS for Category A and C vessels, and 450 lb tail weight per monkfish DAS for Category B and D vessels.
- All limited access monkfish vessels are allocated 40 monkfish DAS to use during FY 2004, but only 28 of those DAS may be fished in the SFMA. Limited access monkfish vessels may fish the remaining 12 monkfish DAS in the NFMA, but must comply with the Northeast (NE) multispecies DAS usage requirements of that area unless fishing in one of the monkfish exempted fisheries, which are further described below. Carryover DAS from FY 2003 may be used in either management area and, thus, may be used in addition to 28 DAS authorized for the SFMA.

A summary of the monkfish trip limits, including the revised trip limits for the SFMA for FY 2004, is provided in the table below.

### **Monkfish Exempted Fisheries**

Enclosed is an information sheet for the monkfish exempted fisheries under the NE Multispecies Fishery Management Plan (Multispecies FMP). An exempted fishery is one that the Regional Administrator has determined will result in a minimal bycatch of regulated multispecies and that will not jeopardize fishing mortality objectives of the Multispecies FMP. In general, vessels are exempt from the requirements to use a NE multispecies DAS when fishing in an exempted fishery. Because monkfish Category A and B vessels do not hold a limited access NE multispecies or limited access scallop permit, and do not have NE multispecies or scallop

DAS, these vessels must fish their monkfish DAS in a monkfish exempted fishery. In addition, monkfish Category C and D vessels allocated less then 40 NE multispecies DAS may also fish the difference between their 40 monkfish DAS and their allocated NE multispecies DAS, as monkfishonly DAS, provided the vessel fishes its monkfish-only DAS in a monkfish exempted fishery. Otherwise, Category C and D vessels are required to use either a NE multispecies DAS or scallop DAS whenever a monkfish DAS is utilized, regardless of where the vessel is fishing. When fishing in any of the monkfish exempted fisheries, the vessel is subject to the trip limits for the management area in which the exempted fishery are located.

### **REMINDERS:**

#### **Monkfish Minimum Fish Sizes**

For vessels **declared into the NFMA**, the minimum fish size is <u>17 inches total length</u>, or <u>11 inches tail length</u>. Such vessels must have available for inspection a valid monkfish exemption certificate (see below), which exempts the vessel from the minimum fish size of the SFMA. This size limit applies to vessels holding a limited access monkfish permit, and to vessels holding an incidental monkfish permit that want to fish under the less restrictive size limit of the NFMA.

For vessels fishing in the SFMA, or for vessels not declared into the NFMA, the minimum monkfish size is 21 inches total length, or 14 inches tail length.

## **Declaration into the NFMA**

All federally permitted monkfish vessels intending to fish for or catch monkfish exclusively in the NFMA under the less restrictive measures of that area must obtain a monkfish exemption certificate from the National Marine Fisheries Service (NOAA Fisheries). This certificate may be obtained by calling (978) 281-9370. This certificate serves as the vessel's declaration into the NFMA, and is issued for a minimum of 7 days. A vessel that has declared its intent to fish in the NFMA may transit the SFMA, provided the vessel does not harvest or possess monkfish, or any other fish, from the SFMA and the vessel's fishing gear is properly stowed and not available for immediate use, in accordance with the regulations.

<u>PLEASE NOTE</u>: A vessel that does not have a current monkfish exemption certificate on board is presumed to have fished in the SFMA, and is therefore subject to the more restrictive requirements of that area, regardless of where the fish are caught or landed. <u>Therefore, unless a vessel has a current monkfish exemption certificate, all monkfish DAS used will be considered to have been fished in the SFMA, and will be applied toward the 28 DAS limit for that area.</u>
