COMMITMENT ITEMS (CI) – REVENUE SOURCE CODE (RSC)

- 1. **Revenue CI.** The Bureau of Reclamation uses CIs to account for the various types of revenue received. In the Financial and Business Management System (FBMS), the general ledger (GL) account derives the CI but it is not detailed enough. When entering revenue, Reclamation manually enters the six-digit RSC to override the CI derived from the revenue GL. Most of Reclamation's RSCs begin with a "Y". The exceptions to "Y' CIs are quarter's revenue, three accounts tied to the FBMS program funds management fee (FMFEE) calculations, investment activity and a few others identified below. The below chart is as of January 28, 2016. For an updated list contact the Reclamation Integration Office.
- 2. **Reclamation Designation.** The name/title/description of Reclamation's revenues with a Y RSC begins with an "R" to designate Reclamation. It is extremely important to differentiate Reclamation's revenues with an "R" because the funds management module reflects all funds at the Department level.
