<u>Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021)</u>: B1.25 Real property transfers for cultural resources protection, habitat preservation, and wildlife management

<u>Description of the Proposed Action</u>: BPA proposes to fund the fee title on property referred to as Looking Glass Ranch. The property has 662 acres of riparian and upland habitat located along the main stem of Lookingglass Creek in Union County, OR – T30N/R39/Sections 10, 11, 12, and 14. This purchase will be made using 2008 Accord dollars committed to the Confederated Tribes of the Umatilla Indian Reservation for the protection of habitat for fish species listed as threatened or endangered under the Endangered Species Act.

The Confederated Tribes of the Umatilla Indian Reservation will develop a management plan to guide the protection and enhancement of habitat on the property. BPA will review the plan for consistency with the mitigation and conservation purposes of the acquisition. If BPA proposes to fund any activities on the property, additional environmental review would be conducted.

<u>Findings</u>: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, July 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.


A Public Notification letter and map will be sent to adjacent landowners and interested parties. Print notification will be in two Union County, Oregon publications.
