## **INSTALLATION COMMANDER'S MESSAGE COLONEL KENNETH O. McCREEDY**

This marks the fourth opportunity I've had to communicate with the retiree community through this publication. As we approach another summer season, there are several important issues I wish to discuss with our readers.

First, I want to express my sincere and pride and heartfelt appreciation for the support and assistance provided in dedicating the Max Beilke Human Resources Center in March. Max Beilke was the epitome of selfless service to the U.S. Army and the nation. He represented the best of the NCO Corps. His life and career were all about taking care of others. We at Fort Meade are fortunate to have an activity named in his honor.

Moving on, by now you may have already heard (hopefully) the good news that this installation took second place in the Army's Community of Excellence competition. With that recognition comes \$1 million award money. As I told the community in a Soundoff! column at the time of the announcement, this is a great testament to the dedication, professionalism and hard work of a customer based workforce that believes in itself and its ability to continuously improve.

As to how we can and should spend the million dollar prize money, the Army's guidance is that the funds are to be used for benefit of the entire community and installation; and used for projects that produce enduring value for the quality of life of residents and stakeholders. . We'll review and harvest your recommendations and establish a committee this fall to develop proposals for spending \$1 million. Remember, think big! It doesn't hurt to dream. Together we can help make Fort Meade an even better place to live, work and enjoy.

Another big development is BRAC. The 2005 Base Realignment and Closure decision will result in major growth in and around Fort Meade during the next several years. Part of that expansion involves the widening and improvement of Maryland Route 175, which runs adjacent to the installation. During a public meeting in March, the Maryland State Highway Administration unveiled six

proposals. It's critical to get this road built. This post isn't an island and it impacts on multiple communities in the area. Fort Meade can work with various alternatives.

The SHA will provide a draft environmental document and conduct another open meeting next year. The planning process is scheduled to end in 2009 when the SHA obtains locations and design approval. Stay tuned for more details. I'll keep you posted through this publication and the Soundoff!

On a related matter, the Enhanced Use Lease or EUL initiative will increase the value of underutilized land to support mission-related needs on the installation. We are presently negotiating now a 50-year lease with the Trammel Crow Co. for them to build two million square feet of office space during the next decade or so to accommodate the additional activities and organizations scheduled to relocate here. As a result of the in-kind services, Fort Meade expects to be able to maintain its infrastructure better while saving the taxpayer's money. EUL is a tremendously powerful tool in helping Fort Meade realize the full value of its land and leverage that value to improve our installation in many ways. More to follow on this.

In the area of transportation, growth such as what will occur in and around Fort Meade during the next decade will put strains on existing roads, as previously mentioned. We're conducting a traffic study of the road network on post to ensure we are prepared to meet greater traffic demands. We are also working with the community to develop multi-modal transit options for people coming to work here. We can make existing transit systems (especially MARC) more effective. For example, Fort Meade is offering to provide land for a transit operations facility in order to stimulate affordable shuttle connections linking the post to the local MARC stations.

In March we opened a new Musculoskeletal Center at Kimbrough. This facility provides outpatient services in orthopedics, chiropractics, podiatry and physical therapy specialties. It is part of a long-term improvement project to renovate and upgrade Kimbrough health care services.

Also in March we upgraded our DEERS and RAPIDS computer systems. This was a DoD-wide initiative to deter possible fraud and abuse of the ID card system. It required us to close the ID card processing section for two days and I apologize for any inconvenience

experienced by our retirees and/or their families.

By now you've probably noticed the changes in the commissary. It's part of an effort to give the store a new look and a more customer-friendly product flow. As the store manager has said, the intent is to make the shopping experience faster and easier – making the commissary the place to go, not just on pay day, but every day.

Operating hours have been changed to accommodate weekend shoppers as well. Early bird shopping is now available from 7 a.m. until regular store hours. Check it out.

Finally, I want to recognize the efforts of our many retirees who give freely to support Fort Meade programs.

In April I had the distinct honor of presenting an appreciation award to Ms. Louise Outlaw, who has served this community for 45 years as a volunteer. Still going strong at a youthful 90, Louise has served with the Main Post Chapel religious activities program since 1962. She's also worked with the local Boy and Girl Scout troops, as well as the Red Cross and USO. As an ACS volunteer, Ms. Outlaw has given her time and talents to military families, helping spouses learn English as a second language and providing child care so they can keep their medical appointments. Louise Outlaw symbolizes the true spirit of our retiree community – still serving, wherever she can.

There's lots happening here and you need to read our award winning weekly newspaper, Soundoff!, to stay informed. This year marks the 90<sup>th</sup> anniversary of Fort Meade and we have scheduled events and activities you may want to attend. And don't forget to attend our Retiree Appreciation Day event on 26 Oct. There's always good information available.

Thanks to your continued support and participation, this truly is a people's post and a Community of Excellence.

Greetings Fellow Retirees and Families!

So much has happened since the last newsletter was sent out in 2006 that it is hard to know where to begin. So, first, I hope that you and yours are doing well health-wise and are planning a safe, enjoyable summer. Do be safe!

Recent stirring Memorial Day services and events remind us that "Freedom is not Free!" At

Fort Meade a Memorial Day Ceremony was held on Thursday, 24 May at the newly established Centennial Park, which is located along English Avenue across from the gazebo on McGlachlin Parade Field. Also, a groundbreaking ceremony occurred which confirms that Centennial Park will be developed at this very location. We hope that the timeline for development will result in completion of the park by 2017 just in time for the 100<sup>th</sup> Anniversary of Fort Meade – we can have a real Centennial Celebration!

Centennial Park will be a wonderful place for quiet contemplation and reflection. A beautiful entrance gate, walking paths, park benches, plaques and memorialized stone markers will provide an ambience of restful tranquility. You can play a role in the development of the Park. All you need do is visit the Fort Meade Museum where information regarding the Fort Meade Museum Historical Foundation is available. The Foundation is working to develop Centennial Park and it is through the Foundation that you can learn how you may become involved.

I thought it important to provide you information about Centennial Park because it is a way for you and your loved ones to become and remain connected not only to Fort Meade but with fellow comrades and heroes who gave so much for our great Country. But, we must move on, so I want to advise you about a number of events coming up so that you can attend and participate. On Saturday, 18 August 2007, we will hold an event that we do every two years entitled the "Surviving Spouse Symposium." The symposium will be held at Club Meade this year where there is room for more attendees and where parking is more accommodating. An excellent selection of speakers has agreed to support the symposium and lunch will be served at a cost we feel is affordable to everyone. So, please complete the enclosed form and return it to (furnish appropriate address) by not later than 10 August 2007. We need a week to confirm final attendance with Club Meade and to assure that space is available for all attendees and the guest speakers. So, please do not delay but send in your registration with payment for the meal as soon as possible. Respective speakers will address medical, legal, social security and

veteran affairs related issues which are especially important to surviving spouses just as they are to military retirees.

On Friday, 26 October 2007, we will conduct the annual Retiree Appreciation Day (RAD) activities. The venue will be similar to that in 2006 when Kimbrough Ambulatory Care Center assisted in making arrangements and then hosting many activities during the morning hours. We intend to make arrangements to allow retirees and their spouses to eat lunch in the Freedom Inn Dining Facility, if desired. Following lunch, we will then assemble in the Post Theater to hear a panel of experts who will address a number of issues prior to opening the floor to your questions. A drawing for several nice door prizes will be held. This always adds fun to the event!

As you can see, we have a number of activities that you can participate in one way or another. And, we want to add a few more new members to the Fort Meade Retiree Council. In the past, I have suggested and encouraged you to read Army Echoes. Please continue to read this very informative newsletter. The May-August issue highlighted comments by General George W. Casey the newly appointed Army Chief of Staff upon his assumption of the top uniformed Army position. He reaffirmed his support for strong families, courageous soldiers, invaluable civilian employees, retirees and the great citizens of America. He concluded with, "We are Army Strong!"

The same Army Echoes provided a good summary of 42 issues that were reviewed and addressed when the Chief of Staff, Army Retiree Council convened from 23 to 27 April 2007. About a third of the issues dealt with health care. The Council took a strong position on continued support of these issues. Some other matters that generated strong support from the Council included full concurrent receipt of military retired pay and VA disability compensation, elimination of the DIC offset to SBP, transformation of the Reserve Component retirement system, and continued support of the Retirement Services Offices. Details are available in Army Echoes on these and a host of other matters. It even encouraged retirees to get involved with their local retiree council – I think I said that a little

earlier! By the way, Army retirees should have received the new Army retired pin by now. It looks great and generates a lot of questions when I wear mine!

Near the end of Army Echoes an article entitled, "VA calls Aid and Attendance under-used benefit" which states that this benefit may be available to many elderly who qualify. Please review the article to see if you or someone you know may be eligible for this under-used benefit. It is never too late to find out about this type of information and best of all you may qualify for a benefit!

Both the Commissary and AAFES are trying to improve services and so please be patient as these facilities go through transformation of sorts. The recent resetting of the Commissary generated some misgivings by some customers. However, by now I think it was worth the effort because I know that the most needed and like items are co-located. However, if you should have questions about these type issues or other customer related matters on Fort Meade let someone know of your concern. Since I currently work at Fort Meade, I answer many questions and our intent is improving service to the customers.

Did you hear that Fort Meade won 2<sup>nd</sup> place in the Army Communities of Excellent 2007 Award competition? It is important to do well in this competition because cash awards are given to the top three competitors. Fort Meade will receive \$1,000,000 for winning second place. The first place winner receives \$2,000,000, so that is Fort Meade's goal for 2008! The winning installations must have outstanding employees who are focused on providing quality service to the customers. That is why it is important that you let someone know if you think services can be improved. Thanks for helping the installation do even better in the future!

Fort Meade is immersed in Base Realignment and Closure (BRAC) activities. Construction for arriving BRAC agencies could reach nearly 1,250,000 square feet of office and administrative space to accommodate 5,700 new jobs. In addition, an enhanced use lease (EUL) project is underway which could include up to 2,000,000 square feet of office and administrative space to accommodate up to 10,000 jobs. As you can imagine, the Fort Meade commander and his staff are working hard to meet the requirements of all this activity. It is truly an exciting time to be involved at Fort Meade!

During this construction period, please be patient as roads will become more congested as construction gets underway.

In closing, I would like to support Mr. Stephen Ashley and his staff at the Fort Meade Retirement Services Office for the support provided to all of us. Also, I cannot say enough good things about Installation Commander Colonel Kenneth O. McCreedy and his entire staff for their assistance and support to retirees. They strive to include us in all aspects of the Fort Meade family. I feel connected and I hope you feel the same way!

#### **NOTES FROM THE COUNCIL CO-CHAIRMAN SGM KENNETH L. MCCALL, SR., USA RET**

It is an extreme pleasure to once again address you through this media and I wish we could do this more frequently, but, budget constraints prevail. Our major concerns continue to be health care which is being addressed not only at the local level, but at the Army Chief of Staff Retiree Council as well. The Kimbrough Ambulatory Care Center recently announced that they have space to accept the enrollment of military retirees and their qualified family members (all must be under the age of 65), into TRICARE Prime (call 1-877/874-2273, or visit their TRICARE Service Center to enroll). Those military retirees and family members over the age of 65 and currently enrolled in Kimbrough's TRICARE Plus program will continue to receive the same level of care that they have been receiving. If you are 65 or older and not enrolled in TRICARE Plus, and need assistance in finding a healthcare provider, call Kimbrough's Beneficiary Counseling and Assistance Coordinators at (301)677-8982.

Senator Barbara A. Mikulski, (MD) continues her mission to "Keep Our Promises to America's Veterans". She along with Senator Benjamin Cardin (MD), recently announced that the Department of Veterans Affairs will open two new community-based clinics in Maryland – one at Andrews Air Force Base (PG County) and the other at Fort Detrick (Frederick County). They are scheduled to be operational in 2007 and 2008 respectively. Senator Mikulski has led a

national effort in establishing out-patient clinics for veterans. Additionally, she has introduced a bill to improve veterans burial benefits (Veterans Burial Benefits Improvement Act), and when approved, will see increases for veterans who die of service-connected disabilities and who are entitled to receive pension or compensation at time of death, or who die in a Department of Veterans Affairs veterans' facility or a nursing home under contract to them, a state veterans' nursing home and for veterans not buried in a cemetery under US jurisdiction (there are several conditions associated with this part). Let them know that you appreciate their efforts and work.

Locally, Anne Arundel County John R. Leopold, recently brought to fruition, a law establishing the Anne Arundel County (AAC) Veterans Affairs Commission and I was honored to be appointed its chairman. The commission is charged with establishing a forum for all AAC veterans of military service by maintaining coordinated communication with county and local governments, businesses and veterans of the county. It also provides assistance, guidance, and information to the business and academic communities of the county and various levels of government to ensure adequate consideration of veterans in employment, education, training and public programs. The commission, composed of 13 residents of the county who are either a veteran or military retiree (All volunteers from the various branches) have an enormous task ahead of it and all are willing to do that which is necessary to get the job done. We will expand our ranks by appointing committees from the veteran community to assist us in our mission. Mr. Leopold recently signed an Executive Order to become effective on 1 July 2007, that will allow all military (both active and retired) and their family members, to use Anne Arundel County parks free of charge. The parks are Down Memorial (Pasadena), Fort Smallwood (Pasadena), Kinder Farm (Millersville), and Quiet Waters (Annapolis). Proper military identification must be shown. Mr. Leopold, a longtime advocate for Veterans' rights and concerns, stated: "I view this new initiative as one more way to honor military personnel and their families for their contributions to Anne Arundel County, the State of Maryland and the United States of America. Their close proximity to the Naval Academy, Fort Meade and Washington, DC, makes our parks ideal places for them to visit and enjoy".

I was recently appointed an Ambassador in the Freedom Team Salute program which was established by the Department of the Army to recognize and honor all "Army Veterans" of the Army, Army Air Force, Army Air Corps, Women's Army Corps, Army Nurse Corps, parents, spouses and employers. If you would like to nominate your spouse or parent for a Freedom Team Salute commendation, please let me know. Again, this program is for Army veterans only. (COL Erwin Burtnick, USA Ret, a council member, is also an FTS ambassador.)

## **ID CARD REQUIREMENTS**

In compliance with Homeland Security Presidential Directive 12 (HSPD-12), the DoD ID card system has been updated to implement new requirements. The establishment of this system will enhance security of federally controlled facilities and computer systems, ensuring a safer working environment. It will also increase efficiency, reduce identity fraud, and protect personal property.

In order to renew or obtain a new ID card, eligible ID cardholders must present two forms of identification (one from the primary list and one from the secondary list, or two from the primary list) as follows:

### PRIMARY

US Military ID Card  
Military Dependent ID Card  
Drivers License or ID card issued by a state or Outlying possession of the US provided it contains a photograph.  
ID card issued by federal, state, or local government agencies or entities provided it contains a photograph.  
US passport

US Coast Guard, Merchant Marine Card  
Permanent Resident Card or Alien Registration Receipt Card with Photograph (INS Form 1-151 Or 1-551)  
Temporary Resident Card (INS Form 1-688)  
Employment Authorization Card (INS Form 1-688A)  
Employment Authorization Document issued by the INS which contains a photograph (INS Form 1-688B)  
SECONDARY  
Certificate of US Citizenship (INS Form N-560 Or N-561)  
Certificate of Naturalization (INS Form N-550 Or N-570)  
Foreign Passport  
Reentry Permits (INS Form 1-327)  
Refugee Travel Document (INS Form 1-571)  
School ID with a photograph  
Voter's Registration Card  
Native American Tribal documents  
Driver's license issued by a Canadian government authority  
US Social Security card issued by the Social Security Administration  
Certification of Birth abroad issued by the Department of State (Form FS-545 or Form DS-1350)  
Original of certified copy of a birth certificate issued by a state, country, municipal authority or outlying possession of the US bearing an official seal.  
US Citizen ID Card (INS Form 1-197)  
ID Card for use of Resident Citizen in the US (INS Form 1-179)  
Employment authorization document issued by the INS.  
Persons under the age of 18 who are unable to present a document listed above may use school record/report card, Clinic, doctor or hospital record; Daycare/nursery school record.

The ID Card Section is located at 2234 Huber Road. Hours of operation are from 0730 to 1530. Please ensure that you have all supporting Documents for changes that are made in DEERS. If you are traveling from a long distance or you are from out of state, please call beforehand if you have questions. The telephone number is (301)677-9586/3342. **All forms of identification must be unexpired.**

### RETIREE APPRECIATION DAYS DIRECTIONS / GATES

**From North** – Travel south on Rt 295 to the Jessup/Odenton exit (Rte 175). Exit east on Rte 175 towards Odenton. Turn right onto Reece Road (3rd light).

**From West** – Travel east on Rte 175, turn right on Reece Road.

**From the East** - Travel Rte 175. Either follow Rte 32 to the Rte 198 entrance or follow Rte 175 and turn left at Reece Road entrance.

**From South** – Travel North on Rte 295 (B/W Parkway) and then east on Rte 198. Take the

circles at Rte 32 and come through Mapes Road entrance or drive North on 95 then east on Rte 32 to Mapes Road entrance.

### DIRECTIONS TO KIMBROUGH AMBULATORY CARE CENTER

Coming from Rte 175 on to Reece Road, turn left on Ernie Pyle Road. Kimbrough is located at the 2<sup>nd</sup> major intersection (Ernie Pyle and Llewellyn Ave) Keep going straight through intersection and take right into the parking lot.

Coming through the Rte 198 entrance follow Mapes to Ernie Pyle Road. Turn right. Directions are the same as above.

For those who will have trouble walking from the parking lot to the main entrance a shuttle cart will be available.
