## **Reclamation Announces Seasonal Recreation Area Closures and Seasonal Changes to Park Hours at Lake Berryessa**

**NAPA, Calif.** - The Bureau of Reclamation, Central California Area Office, has scheduled a seasonal closure of the north side of Oak Shores Day Use Area and the two restrooms along the Smittle Creek Trail at Lake Berryessa beginning Monday, Oct. 5, 2015, through Friday, April 1, 2016. The south side of Oak Shores will continue to offer restroom facilities, picnic tables, barbecue grills, water access and a kayak/canoe hand launch. This seasonal closure allows Reclamation to perform necessary maintenance tasks and also provides time for natural resource recovery. All other Reclamation-operated locations will remain open year-round.

Seasonal changes to park hours include the following Reclamation-operated areas: Oak Shores Day Use Area, Smittle Creek Day Use Area and Eticuera Day Use Area:

- Beginning Monday, Sept. 14, gates will close at 7 p.m. to reflect changes in daylight hours.
- Beginning Monday, Oct. 19, through Monday, March 14, 2016, gates will close at 5 p.m.

The Capell Cove Boat Launch Ramp is currently closed due to drought conditions and receding water levels; the launch ramp will re-open when water levels rise. Boaters are encouraged to use other ramps at Lake Berryessa, including those at the Putah Canyon Recreation Area, Steele Canyon Recreation Area, Pleasure Cove Marina, Spanish Flat Recreation Area and Markley Cove Resort (see the map at [www.usbr.gov/mp/ccao/berryessa/index.html](http://www.usbr.gov/mp/ccao/berryessa/index.html)).

Please note that these concession areas charge a fee to use their launch ramps. Please contact the locations to ensure launch ramps are still in operation prior to traveling as some will likely be closing soon due to low water levels. For information, please visit the following websites:
