EPA PROPOSAL FOR REID GARDNER GENERATING STATION

ANNOUNCEMENT OF PROPOSED BART DETERMINATION, OPEN HOUSE AND PUBLIC HEARING, AND EXTENDED REQUEST FOR PUBLIC COMMENT EPA-R09-OAR-2011-0130

The Region 9 Office of the United States Environmental Protection Agency (EPA) requests public comment on a proposed source-specific Federal Implementation Plan (FIP) for implementing Best Available Retrofit Technology (BART) at Reid Gardner Generating Station (RGGS) located near Moapa, Nevada. The Clean Air Act's Regional Haze Rule requires the use of BART at older coal-fired power plants to reduce haze and improve visibility in nearby national parks and wilderness areas.

EPA proposed requiring RGGS to meet limits on emissions of nitrogen oxide (NO_x) from Units 1, 2 and 3 in a Federal Register Notice published on April 12, 2012, which is available on Region 9's website at http://www.epa.gov/region9/air/actions/nv.html. The FIP establishes an emissions limit of 0.20 lbs/MMBtu (pounds per million British thermal units) for Unit 3, and requires the determination of emissions from Units 1, 2 and 3 based on a 30-day rolling average (averaged across all three units). In the same notice, EPA also proposed to approve Nevada's revision to its Regional Haze State Implementation Plan that requires an emission limit of 0.20 lbs/MMBtu on NO_x from Units 1 and 2 at RGGS.

This announcement provides notification that EPA is holding a second informational open house and public hearing for the public to comment for the record on May 3, 2012 at The Big Auditorium in the Moapa Band of Paiutes Administration Building on 1 Lincoln Street (cross street is Reservation Road) in Moapa, Nevada.
