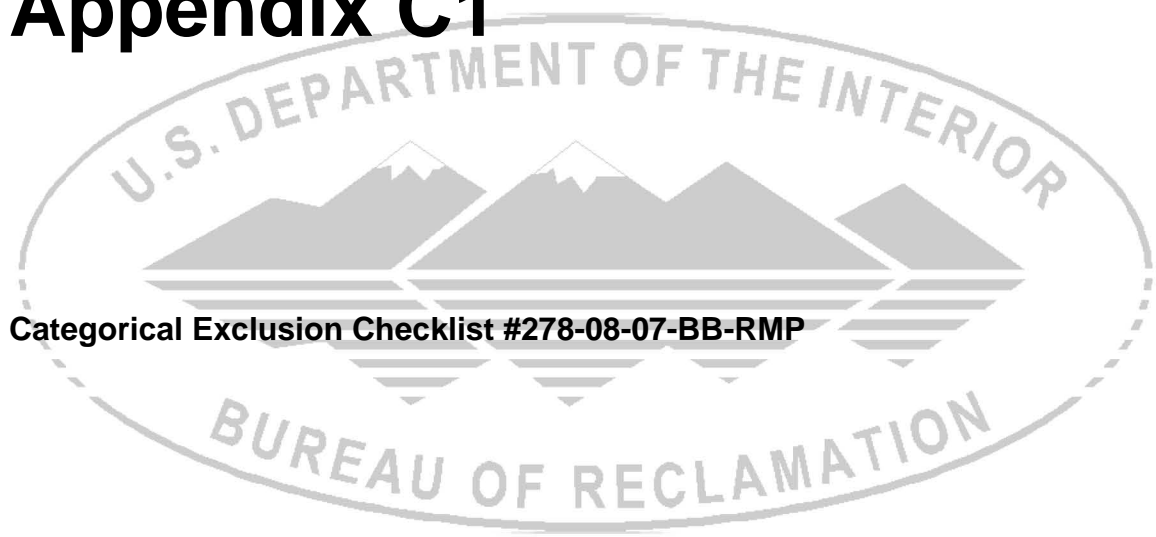

NATURE OF ACTION: The Bureau of Reclamation's (Reclamation) Nebraska-Kansas Area Office, in cooperation with the Nebraska Game and Parks Commission (Commission), has developed the Box Butte Reservoir Resource Management Plan (RMP) in accordance with Public Law 102-575, Title 28, Section 2805 (106 Stat. 4690), Reclamation Recreation Management Act of October 30, 1992; which provides Reclamation with the authority to prepare an RMP. This RMP serves as a guideline for land use and resource management decisions to ensure public resources are used according to recognized standards, while considering the needs and desires of the public. This RMP replaces the 1985 Reservoir Area Management Plan. The purpose of the RMP is to establish a 10-year plan detailing the administration and management for the conservation, protection, enhancement, development, and use of resources at Box Butte Reservoir. The scope of this RMP includes the 2,260 acres acquired by Reclamation at Box Butte Reservoir. Specific land uses for Box Butte Reservoir are recreation, fish and wildlife, and operations. Discussed in the RMP are the following topics; land use, recreation management, fish and wildlife administration and management, agency responsibilities, and reservoir operations.

NATURE OF ACTION (CONTINUED)

The primary management actions anticipated under the Box Butte Reservoir RMP include:

- Surveys – Reclamation has contracted and completed legal property boundary surveys and has monumented all lands at Box Butte Reservoir that were acquired to elevation 4012'.
- Fencing – Reclamation has constructed new boundary fence, in areas where no boundary fence existed in the past.
- Access – Reclamation acquired a perpetual easement on private lands for the construction of a new all season public access road and parking lots.
- ADA – Reclamation and the Commission have entered into a cooperative agreement to provide funding for facility upgrades to meet accessibility standards.
- Land Use Authorizations – Reclamation has negotiated Land Use Authorizations with adjacent landowners to document and temporarily allow use of Reclamation lands.

According to Lease Agreement #14-06-700-3816-A, the Commission is the administering agency for the recreation facilities and activities at Box Butte State Recreation Area and for the wildlife management activities at the Box Butte Wildlife Management Area. This agreement was executed May 1, 1995 (amended May 16, 1997, September 10, 1997, and February 5, 1998, June 8, 2001, November 22, 2002, September 24, 2003) and is in effect for a term of 25 years. The Commission has completed the 2008 Box Butte Wildlife Area Management Plan, and the 1995 Box Butte Reservoir Lake Management Plan. These plans address specific management activities at Box Butte Reservoir and are included in Appendix A of the RMP.
