Huber: How many cylinders have the DUF6 plant processed?	Bradburne: I am not sure of the exact amount of cylinders. The last couple of months they have been running some start up testing. Over the holidays they ran one line, but not up to production mode yet.

Question/Comment:	Answer:
<i>Francis:</i> What kind of businesses are in the \$27.1 million in procurements? It would be interesting to see a breakout of how much in what type of business.	Schneider: Mechanical, sanitation, hardware, lumber, equipment, catering, services, supplies
Minter: Is there a way to track how many jobs are created because of the plan?	Schneider: No, it cannot be tracked. It has been tracked at other sites, but everyone was always discussing who gets the credit. Fluor-B&W wants to shoulder up with entities such as SODI and OhioMeansJobs and have a grand total of jobs being created.
Cosby: I would like to thank FBP for its donation to the National Association for the Advancement of Colored People (NAACP). The NAACP (branch) serves a three county area, Jackson, Gallia, Lawrence counties. We also help Pike county because it does not have a NAACP branch.	

Administrative Issues:

Snyder: I would like to report on the Intergovernmental Meeting I attended in December. It was a very good meeting. It was interesting to see what Environmental Management (EM) is focusing on these days, like streamlining the budget. Interfaced with state representatives, it was interesting to see their views, but I was disappointed that there were no representatives from this area. Shelly Cimon from the Hanford Site and I were the only SSAB members attending. I would encourage you all to sign up next time and if funds are available, maybe we can send you.

Roberts: The Paducah site will be hosting the National Chairs meeting April 16-19.

Comments from the board:

Renner: FBP is having a Public Meeting Jan 31st. As a board member, we have seen different areas with different types of cells. In the 10-year plan, the future use is nuclear energy. We will be ready. If our D&D goes out 25 to 30 years, we will be too late to take advantage of these opportunities.

Huber: I would like to see EHI arrange for the Site Legacy Subcommittee to meet because we have not met for a few months. I would like an update on the virtual web site, archeology study.

Henderson: I would like a follow-up on the fracking education. OU said they could help us with some training on this and I would like to see this happen. Before people in this area are taken advantage of, like the surrounding areas have been.

Public Comment:

Sea: The Portsmouth plant has been shut down for more than 10 years. There is no reason for the secrets and classified information. I was disappointed when the question was ask about declassifying some of the information and Joel answered that they are waiting on headquarters and no one from the board had any follow-up questions. No businesses will want to locate on the site if they do not declassify that information. They will want to know what was here.

Manuta: The barrier is the technology. I do not think that they do not want to release the information, but because of lost, shredded materials, the information is not available. If you are tearing down the X-100-type buildings, which includes the hospital, please make sure they get all the file cabinets and all files out before the wrecking ball hits it, or that information will be lost, too. I will be testifying on a trial in West Virginia on fracking in February and this trial will affect what happens in Ohio.

Final Comments from the board:

Brushart: I would like to thank whoever is responsible for the Christmas Dinner at the golf course. It was very nice.

Francis adjourned the meeting. Next Meeting Thursday, February 2, 2012, 6 p.m.

- EHI will work with FBP and DOE about setting up a foot tour of the woodlands, including the potential on-site waste disposal cell sites C and D, habitat survey area, archeology study area and any other areas that other SSAB members are interested in seeing, as requested by Huber.

► USEC operates the American Centrifuge Project and recently returned the gaseous diffusion plant back to DOE.




➤ WEMS is the Facility Support Services contractor for infrastructure maintenance, training, security and other site services.

RSI is the ETS contractor that assists DOE with strategic planning, oversight, regulatory support and technical support.












