Liaison comments provided by Maria Galanti, Ohio EPA

Galanti: We should have the Remedial Investigation/Feasibility Study (RIFS) sometime by the end of the month, followed by several other documents. I encourage you to look at them and talk with us so you understand what the RIFS is about. We are moving along well. We will have a busy fall and winter with document review, which will lead to a lot more fieldwork.

Starting to work on the Consent Decree Agreement. The supporting documents feed into the overall documents and how we are going to look at the soils and groundwater. Until we decide how we are going to address the remaining units under the Consent agreement, soils will not be addressed. We have to talk about the background in order to address how clean is clean and what happens with soil and where it is going to go. There is a lot of work to do between DOE and OEPA. Those decisions are not yet made.

As the proposed Plan is presented and the WAC is being developed, all those things you just talked about are major players in what will become the law of the land.

In order to look at consolidation of the existing closed landfills you will need new orders or a request from DOE. That is something we would like to be abreast about. Because when you look at the ending, if consolidation of the landfills is impossible then it changes everything. After all the work, we have looked at, we do not want the process to get beyond us. The request has to come from DOE, not the contractor right?

Snyder: Remedial Investigation Feasibility Study (RIFS), corrective measures studies (CMS). Are you going to incorporate all the existing landfills into the new disposal cell? Will that be incorporated into archive CMS?

How do you address the Resource Conservation and Recovery Act (RCRA) Facility Investigation (RFI)? Just because these documents are concurred with or approved documents, there is still always room to make adjustments. You have to understand there will be some lag when we talk about the final cleanup criteria and where all that soil can go.

We are working on that. We do need a formal request from DOE.

Yes, the request needs to come from DOE.

Galanti: No

That will be a separate decision. Those remedies are in place, as are many other remedies. They are undergoing operation and maintenance (0&M), so we have to work with DOE to find a process on how to address the existing landfills and the contamination. There are other things we have to talk about. DOE has to get regulatory relief from the agency, and we have to agree that DOE's actions are being protective of human health and the environment. There are special orders they would have to get from our director that would grant them the regulatory relief they need to be able to address those soils. Until a decision is made on a waste cell disposition and no decision has been made, it is hard for us to give regulatory relief. In the end, there will be one document with all the decisions documented in one place.

What is the status of the regulatory relief?

Bradburne: It is tough to say because it is all like a big melting pot and you have to progress each week. Before we actually get the background ready for release, we will come in and present it to the board. It is a scientific study that shows what contaminants we have in the area of the site and where they come from, the gaseous diffusion process or something else, like weapons testing fallout. You use the scientific findings as a basis to use for making decisions.

Is the timeline for the Proposed Plan the end of September?

Galanti: The time line for the RI/FS is the end of September. DOE has not given me any relief on the Proposed Plan. I will have 45 days to review. My understanding for the Proposed Plan is March.

Will the Proposed Plan include the decision on the on-site waste disposal cell, and the consolidation of the existing landfills?

Let us break it down. You have two regulatory documents out there. The RI/FS that is coming to me and it deals mostly with all D&D. Everything else is in the Consent Decree agreement. Those studies have not been completed. DOE can come to us for relief for dealing with soils, but until I know what the other remedies will be, they can say we are going to require relief from the existing remedies, and propose a presumptive remedy, which is digging it up. Then we need to decide if you are being protective of human health.






Groundwater Treated: 26.3 Million Gallons in FY2012







INTRODUCTION

The Portsmouth Gaseous Diffusion Plant (PORTS) Site Specific Advisory Board (SSAB) is a stakeholders' board, chartered to provide advice and recommendations to the U.S. Department of Energy (DOE) on decontamination and decommissioning, environmental remediation, waste management and related issues at the Portsmouth Site. The Portsmouth/Paducah Project Office (PPPO) manages the Environmental Management (EM) activities in Portsmouth.

The SSAB is comprised of up to 20 members, chosen to reflect the diversity of gender, race, occupation, views, and interests of persons living near the Portsmouth Site. The board is committed to reflecting the concerns of the communities impacted by environmental management of the plant site. Besides DOE, the Ohio Environmental Protection Agency (OEPA) and Ohio Department of Health (ODH) are represented in an advisory capacity.

The scope of the SSAB is to provide advice and recommendations concerning the following EM site-specific issues: environmental restoration; waste management; recycling; future land use and long term stewardship. The Board may also be asked to provide advice and recommendations on any other EM projects or issues.

The Board meets bi-monthly to hear presentations by persons working on relevant environmental management topics, listen to and discuss input from citizens, consider recommendations developed by the PORTS SSAB subcommittees, and perform other business. The Board strives for consensus in reaching decisions and conducts business under a set of bylaws, standing rules, and special rules of order, which incorporate the principles of *Robert's Rules of Order*.

Every month SSAB members participate in subcommittees to focus on various topics related to site cleanup. Active subcommittees for the fiscal year 2013 were established based on project priorities, as selected by the SSAB members, with guidance from DOE. They are:

- Site Legacy
- Waste Disposition and Recycling
- Site Optimization and Future Land Use
- Community Engagement
- Budget and Funding
- EM National Chairs Planning

This Work Plan addresses the SSAB priorities for the 2013 Fiscal Year. Although the Board intends to structure its activities to focus on the priority projects, it is understood that other topics may present

themselves that could result in deviation from the Work Plan. A prescribed process is followed to alter the SSAB work plan with alterations accepted and approved by both the SSAB and DOE.
