Question/Comment:	Answer:
Roberts: The switchyards 1.8 million pounds, how does that convert to the 2.2 million cubic yards of waste?	Mingus: I will have to sit down and figure that out for you. However, the next page will show you the steps we go through.

<p>How do you handle the subjective questions, like workers safety? You can tell if it is safe or not, but does it affect the workers safety?</p> <p>Sometimes when you look at recycling, the community feels like you just say you are not going to recycle something because of workers safety, just so you do not have to go the extra effort to recycle.</p> <p>When looking for an outlet how much falls to you and to Southern Ohio Diversification Initiative (SODI)?</p> <p>We are laying the groundwork for the Record of Decision (ROD) and what goes into the Waste Acceptance Criteria (WAC).</p>	<p>Galanti: In the 100 building, you would not go in and take the vents out. Was it worth the workers safety to go in and try to cut the vents out? When you look at how many hours it will take, there is an equation you do that looks at the workers safety level, to see if it is worth it.</p> <p>Mingus: We go after everything we can.</p> <p>SODI is an outlet, but not the only one. We will look for other outlets to recycle.</p> <p>Simonton: We have things that SODI did not want and we found other outlets to take them.</p>
<p>Yeager: How can you prove that an item is clean?</p>	<p>Mingus: Radiation Absorbed Dose (RAD) testing.</p> <p>Simonton: We look at the history of each item, what material it is, the documentation, everything is tested.</p>
<p>Payton: Have you recycled any concrete?</p>	<p>Mingus: No, not yet, We have looked at recycling concrete but we do not have an outlet for it right now.</p>
<p>Hartley: What money value is that to the government?</p>	<p>Mingus: \$56,000 cost, but saved about \$7.2 million.</p> <p>Simonton: We have been able to get a little money back, but we saved over seven million dollars by recycling.</p>
<p>Halstead: There has not been a decision on nickel yet.</p>	<p>Mingus: No, no decision has been made yet.</p>
