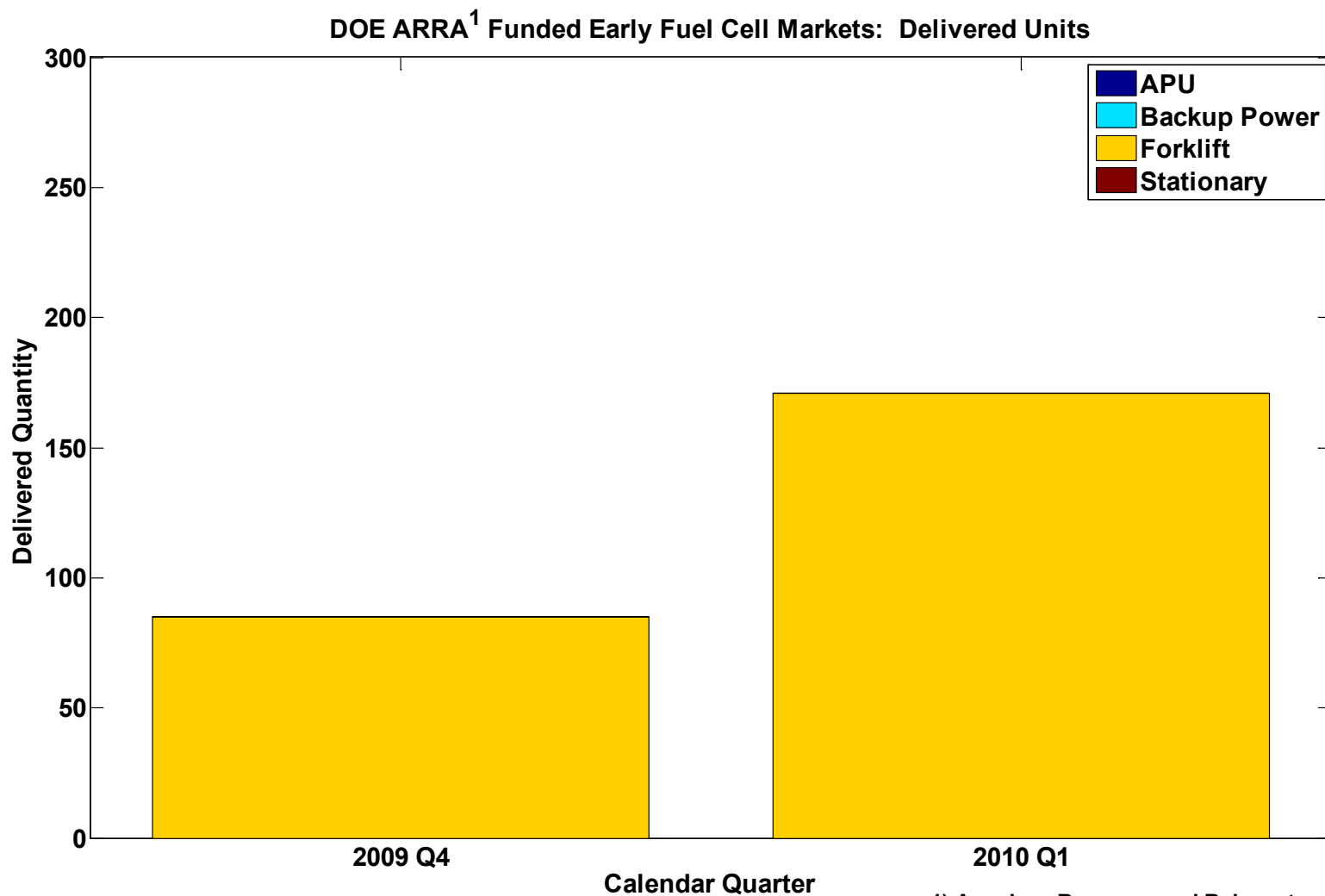

# CDP ARRA#01: Fuel Cell Units Delivered to Site



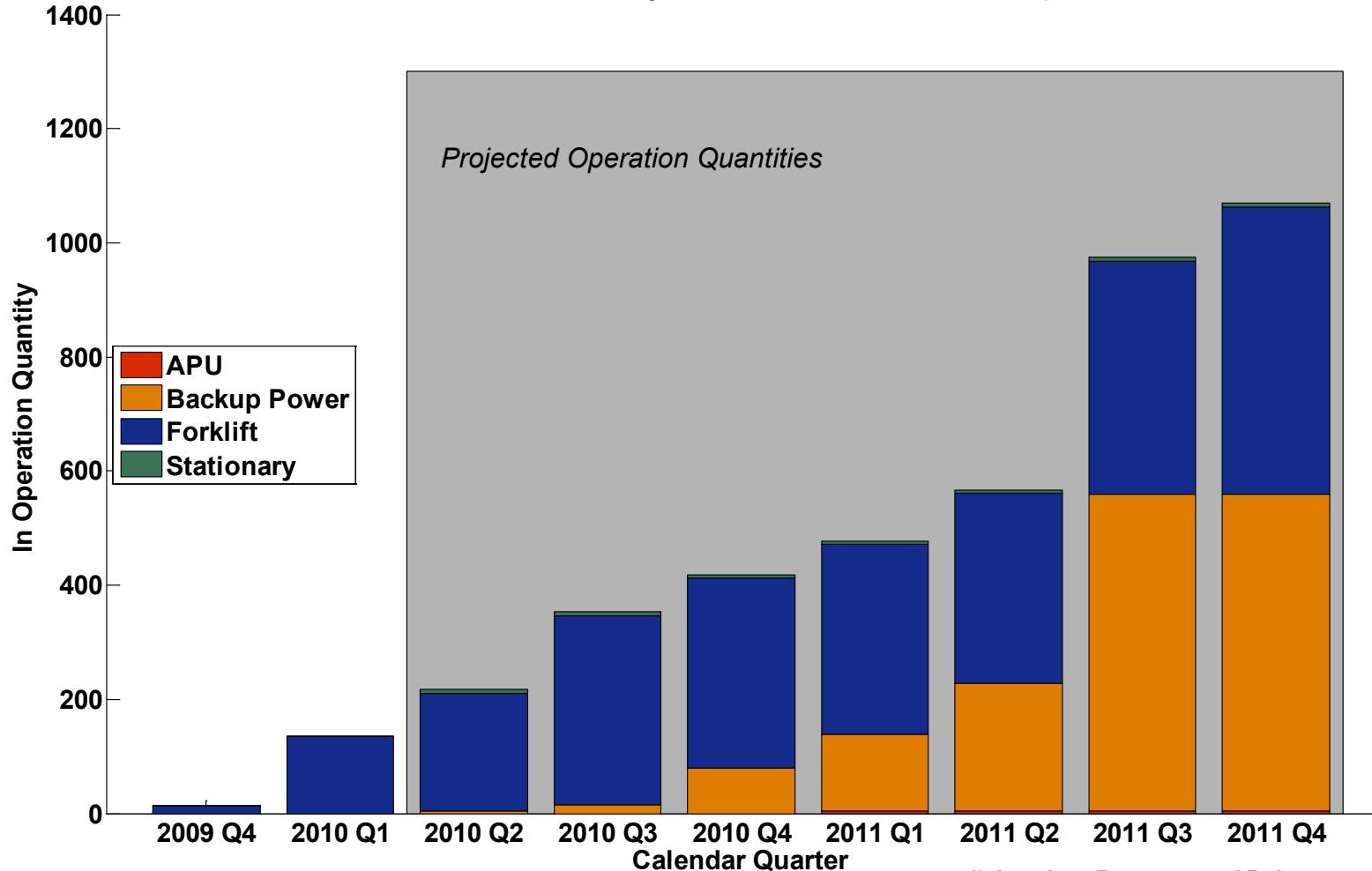

DOE ARRA<sup>1</sup> Funded Early Fuel Cell Markets: Units in Operation

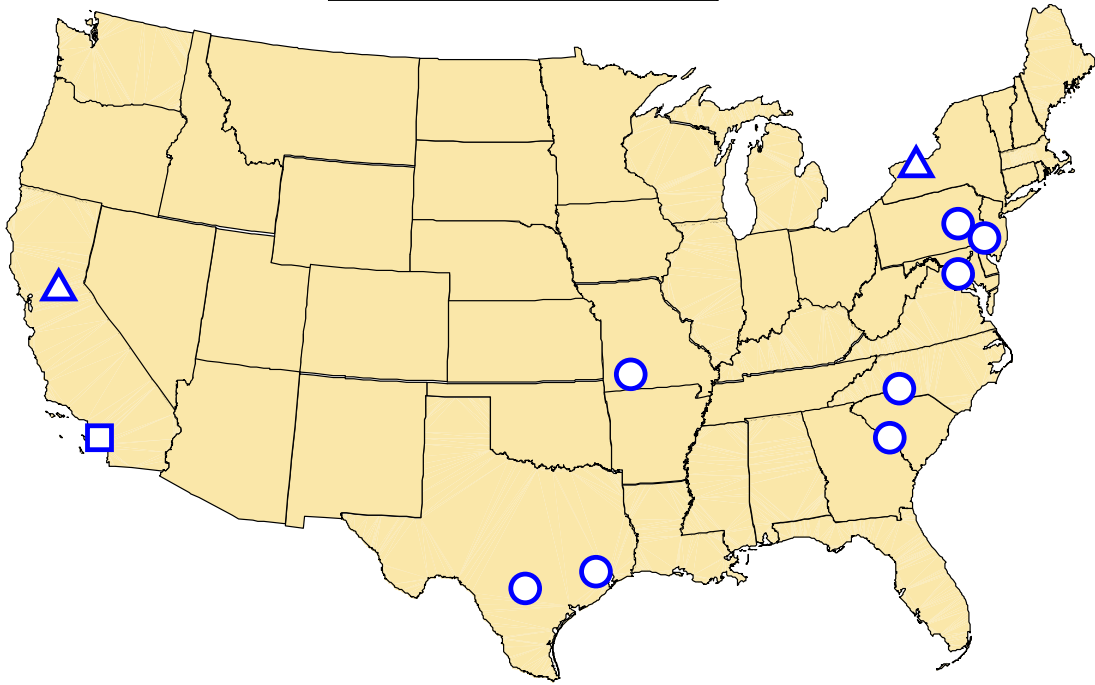
