PRELIMINARY CERTIFICATE OF APPORTIONMENT OF \$382,403,357 OF THE APPROPRIATION FOR PITTMAN-ROBERTSON WILDLIFE RESTORATION TO THE STATES, THE COMMONWEALTH OF PUERTO RICO, GUAM, THE U.S. VIRGIN ISLANDS, AMERICAN SAMOA, AND THE COMMONWEALTH OF THE NORTHERN MARIANA ISLANDS FOR FISCAL YEAR 2013

Pursuant to the Pittman-Robertson Wildlife Restoration Act, as amended (16U.S.C. 669 et seq.), The U.S. Fish and Wildlife Service (Service) has apportioned \$382,403,357 to the States, the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands. The funds so apportioned are based on the amount credited during the first nine months of Fiscal Year 2012 to the Wildlife Restoration Fund. The funds are available for the fiscal year beginning October 1, 2012, and are available for the periods of time specified in the Act.

Of the total amount apportioned, The Service has made \$301,365,829 available to the States as provided by Section 4(b) of the Act. The amounts apportioned to the States are adjusted so no State shall receive more than five percent or less than one-half of one percent of the amount apportioned under Section 4(b). Amounts apportioned to the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands are as provided by Section 8a of the Act.

Of the total amount apportioned, the Service has made \$73,037,528 available to the States as provided by Section 4(c) of the Act. The amounts apportioned to the States are adjusted so no State shall receive more than three percent or less than one percent of the total apportioned under Section 4(c). Amounts apportioned to the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands are as provided by Section 4(c) of the Act.

Of the total amount apportioned, The Service has made \$8,000,000 available as provided by Section 10(a) of the Act. The amounts apportioned to the States are adjusted so no State shall receive more than three percent or less than one percent of the total apportioned under Section 10(a). Amounts apportioned to the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, and the Commonwealth of the Northern Mariana Islands are as provided by Section 4(c) of the Act.

Therefore, in accordance with the above, the preliminary apportionment of Pittman-Robertson Wildlife Restoration funds for Fiscal Year 2013 is as shown on the enclosed tabulation.



Pursuant to the Dingell-Johnson Sport Fish Restoration Act, as amended (16 U.S.C. 777 et seq.), the U.S. Fish and Wildlife Service has apportioned \$231,138,658 to the States, the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, the Commonwealth of the Northern Mariana Islands, and the District of Columbia. The funds so apportioned are based on the amount credited during the first nine months of Fiscal Year 2012 to the Sport Fish Restoration Account. The funds are available for the fiscal year beginning October 1, 2012, and are available for the period of time specified in the Act.

The amounts apportioned to the States are as provided by Section 4 of the Act, and adjusted so no State shall receive more than five percent or less than one percent of the total amount apportioned.

The amounts apportioned to the Commonwealth of Puerto Rico, Guam, the U.S. Virgin Islands, American Samoa, the Commonwealth of the Northern Mariana Islands, and the District of Columbia are as provided by Section 12 of the Act.
