Historic preservation work at the Miller House is wrapping up this month, with the Refuge's premier cultural resource now sporting new logs that will help maintain the structure's integrity (figure 3). The aging wooden buildings known as the Miller Ranch have been on site since the turn of the 20<sup>th</sup> century.

The Miller House and surrounding land was the first property purchased by the Federal government to become part of the National Elk Refuge, which was established in 1912. The Miller House is open during the summer season, allowing visitors to step back in time and listen to stories of homesteading, ranching, and conservation.

**DOI**—The Paleontological Resources Preservation Act Proposed Regulations are complete and have been sent to the Federal Register for publication. The Rule will enable DOI to properly permit research on these resources and to implement the casual collecting component of the Act.
