INTRODUCTION

K.S.A. 65-3405 requires the development of county solid waste management plans. This report reflects solid waste data collected from facilities for calendar year 2014 and any other activities and policy decisions made since the last update.

DEMOGRAPHICS

Sedgwick County consists of 20 incorporated cities and 26 unincorporated townships. Over 75% of the County's population lives in Wichita. U.S. Bureau of the Census data shows that Sedgwick County's population in 2013 (the most recent data available) was 505,415. Population is expected to grow 0.4% per year through year 2030, expanding to approximately 531,888 citizens. Table 1 shows census data for Sedgwick County and the cities within Sedgwick County.

SOLID WASTE MANAGEMENT COMMITTEE

MSW Collection

The solid waste management system in Sedgwick County is private sector driven. Seventeen businesses were licensed to haul non-hazardous waste in 2015. Table 3 lists these businesses.

Solid Waste Trends

Over the past five years, the work of local businesses and citizens has resulted in a decrease of solid waste and an increase in recycling. County leaders support this trend and encourage these free market efforts. Sedgwick County expects cities in the County to adopt a free market approach to solid waste disposal in lieu of having a contract or franchise for solid waste services. This encourages the entrepreneurial spirit and empowers citizens to make their own decisions in regards to solid waste disposal.

Table 4 shows the solid waste collection details for all cities in Sedgwick County.

SW Disposal

Waste Connections Transfer Station reported that 285,742 tons of solid waste was received at their facility during 2014. Waste Disposal, LLC Transfer Station reported that 102,139 tons of solid waste was received at their facility during 2014. Totally, 387,881 tons of solid waste was received at these two transfer stations during 2014, which is a 3.1% decrease from the previous year.

The MSW from both transfer stations was transferred to Plumb Thicket Landfill in Harper County for final disposal. The Plumb Thicket Landfill has a site life of 60 years at current volumes. Figure 2 shows Sedgwick County MSW disposal trends for the past five years.






Figure 3 shows the amount of MSW generated per person per day in Sedgwick County for the past 5 years.



SOLID WASTE REDUCTION

Amount recycled in Sedgwick County

Tonnage reports for the materials shipped for recycling in 2014 were submitted by five material recovery facilities in the county. Waste Connections Recycling Facility shipped 25,554 tons; International Paper shipped 25,548 tons; Pratt Industries shipped 14,400 tons; Best Value Services, LLC shipped 856 tons; and ProKansas-Miller Recycling Center shipped 699 tons. The total reported by the facilities is 67,057 tons. This is a 16% increase over the amount reported the previous year. Sedgwick County's combined commercial and residential recycling trends for the past 5 years are shown in Figure 4.



Drop-off recycling

Waste Connections continues to provide drop-off recycling bins at area grocery stores around Sedgwick County. These single stream bins collected newspapers, tin and aluminum cans, magazines and catalogs, office papers, corrugated cardboard, chipboard, plastic bottles and containers, and food and beverage glass containers. In addition, International Paper has drop-off boxes for fiber products in their parking lot. These drop-off boxes are for use by the general public. ProKansas-Miller Recycling Center accepts most types of plastic containers, plastic bags, mixed paper, metals, books, and glass.

Curbside recycling

Obtaining data on the number of residential customers using curbside recycling service is difficult due to the number of haulers in our area. However, the largest hauler reported that 44% of their customers in Sedgwick County have the service.

Composting in Sedgwick County

Brooks Construction and Demolition Landfill is open to the public and operates a compost site at their location at 4100 North West Street in Wichita, Kansas. They reported receiving 521 tons for composting. Evergreen Recycle at 302 West 53rd Street North is open to the public. They operate a compost site and a pallet refurbishing business. Evergreen reported receiving 19,703 tons for composting and/or pallet construction. The cities of Clearwater, Colwich, Derby, Haysville, Mount Hope, Sedgwick, and Valley Center maintain small brush piles and/or compost sites for their residents' use.

Management of grass clippings

Residents are encouraged to mulch mow or compost their grass clippings. Grass clipping are accepted at numerous compost sites located throughout the county. These sites are listed under the compost section of this report.


Household Hazardous Waste


The Sedgwick County Household Hazardous Waste Facility is located at 801 Stillwell in Wichita, Kansas. In 2014, 21,763 participants brought 1,165,815 pounds of material (excluding solid waste) to the HHW Facility. Included in these numbers are the 4,077 participants that brought 8,620 pounds of old or unused pharmaceuticals.

Conditionally Exempt Small Quantity Generators

In 2014, 318 conditionally exempt small quantity generators brought in 79,641 pounds of waste to the Sedgwick County Household Hazardous Waste Facility.

Of the total brought to the HHW facility, 723,221 pounds were reclaimed by 9,678 Swap and Shop customers. Sedgwick County provided five remote collection events in 2014. HHW volume and customer trends are shown in Figures 5 and 6.







Construction & Demolition (C&D) Materials

Commercially generated construction & demolition materials are banned from the transfer stations in Sedgwick County. There are two Construction & Demolition Landfills in Sedgwick County that accept this waste. Both facilities are open to the public.

During 2014, Brooks C & D Landfill received and buried 107,683 tons of waste and CDR - North received and buried 66,505 tons of waste. The total for all C & D waste buried in 2014 is 174,188 tons. This is a 12.5% decrease from the amount reported the previous year.

C&D Landfills pulled concrete, metal, asphalt shingles, and tree and wood waste from loads brought to their facilities. Brooks reported recycling 808 tons. CDR – North did not report their recycling tonnage.





Bulky Waste

From July 14, 2014 to November 5, 2014, Sedgwick County promoted a bulky waste coupon program. County residents could request a coupon that would pay the disposal fees charged at local transfer stations for loads up to 1,000 pounds. Of the 6,002 coupons that were issued, 2,450 coupons were redeemed.

Waste Tires

Waste tires have been an issue for decades. Before regulations that controlled tire storage, local businesses stockpiled large numbers of waste tires. These large piles posed fire hazards and health and environmental risks. Waste tires are improperly stored on some farms and residential land and have been and continue to be an illegal dumping problem.

In the early 1990's, the Kansas Department of Health and Environment removed over one million tires from a large pile on South West Street in Wichita. In 2000, Sedgwick County partnered with the Kansas Department of Health and Environment to offer the first Waste Tire Amnesty program. This program ran for seven days and exceeded all expectations of state and local officials when 2,180 tons or 218,044 passenger tire equivalents were collected from 5,630 vehicles. These tires came from Sedgwick County residents and farmers. Businesses were not eligible to participate in the program per KDHE rules. KDHE paid \$301,282.89 for the transport, handling, and disposal of these tires.

In 2004, Sedgwick County repeated a Waste Tire Roundup for residents, farmers, governments, and businesses. The six-day program was funded by the County's Solid Waste Fee and collected 2,226 tons or 222,638 passenger tire equivalents from 3,569 vehicles. Transport, handling, and disposal costs were \$190,721.09.


A third Waste Tire Roundup was held in 2011for residents, farmers, and businesses, with one day set aside for government agencies. The four-day program was funded by the County's Solid Waste Fee and collected 1,558.78 tons or 155,878 passenger tire equivalents from 1,866 vehicles. The transport, handling, and disposal cost was \$138,002.88.


A fourth Waste Tire Roundup was held at the Public Works West County Yard on April 16, 17, & 18, 2015. This event was held for residents, farmers, businesses, and government agencies. Tire dealers and other businesses that collected fees for tire disposal were not eligible to participate. April 16 was promoted as the day for businesses and government agencies.


Sedgwick County Public Works managed the large tire piles and the flow of traffic through the yard. The vendor, Champlin Tire Recycling, was present during the event and hauled the tires from the site to their tire monofil in Concordia, KS. The program was funded by the County's Solid Waste Fee and collected 1,378 tons or 137,780 passenger tire equivalents from 2,054 vehicles. The transport, handling, and disposal cost was \$123,999.30.

Trends emerge when analyzing the data collected from the four waste tire collection programs held in Sedgwick County. The overall tonnage of waste tires collected is decreasing. Vehicle counts have

also trended down with a slight increase from 2011 to 2015. These trends are shown in Figure 1. Figure 2 shows that the tonnage collected per day has steadily increased with each program. And, the size of loads peaked in 2011 as shown in Figure 3.

Storm Debris

On January 21, 2015, the Sedgwick County Board of County Commissioners repealed two resolutions pertaining to the reimbursement of cities for storm related expenses. The County is currently developing a new storm debris disposal plan.

Christmas Trees

From December 20, 2014 through January 13, 2015, Sedgwick County provided 21 sites throughout the County for residents to drop off Christmas trees. Residents were also invited to take free mulch home with them. The program collected 4,200 trees. In addition, some small cities in Sedgwick County also operate their own Christmas tree disposal program.

KDHE SOLID WASTE PERMITS

KDHE requires that any solid waste permit must first be approved by the local government as to its consistency with the local Solid Waste Management Plan. One solid waste permit application was reviewed and approved from June 2014 to June 2015.

Stericycle, Inc. relocated their medical waste transfer station facility. The move required a new permit. Their Solid Waste Transfer Station permit was reviewed and approved by the Solid Waste Committee on September 8, 2014. The permit was reviewed and approved by the Board of County Commissioners on November 19, 2014.

KDHE GRANT APPLICATIONS

KDHE requires that all grant applications come before the Solid Waste Management Committee. There were no grant applications from June 2014 to June 2015.

PUBLIC EDUCATION

Sedgwick County continues to make numerous efforts to inform and educate citizens and businesses about issues related to solid waste in Sedgwick County. Staff interacted with the public at trade shows and numerous presentations. Staff made ongoing updates to an online recycling guide. The guide can be found at: http://Sedgwickcounty.org/environment/recyclingguide.asp. Numerous promotional items and educational pieces we developed and distributed to the public.

SOLID WASTE FEE

Sedgwick County utilizes a Solid Waste Fee to help fund certain components of the Solid Waste Plan. On June 4, 2014, the Board of County Commissioners voted to keep the Solid Waste Fee. For 2014, the annual residential base rate is \$6.48. For non-residential commercial owners, the base fee would be established at \$5.94 with differentiating amounts depending on the property class tier assignments for non-residential properties. A copy of the Solid Waste Fee resolution can be found in Appendix A.

Appendix A

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS ADOPTED PURSUANT TO K.S.A. 65-3410, IMPLEMENTING AND ESTABLISHING A SCHEDULE OF FEES TO BE ASSESSED AGAINST AND CHARGED TO REAL PROPERTY WITHIN THE COUNTY'S SOLID WASTE SERVICE AREA; PRESCRIBING THE USE AND EXPENDITURE OF REVENUES FROM SUCH FEES AND ESTABLISHING THE BOUNDARIES OF THE COUNTY'S SOLID WASTE SERVICE AREA.

WHEREAS, the Board of County Commissioners (the "Board") of Sedgwick County, Kansas (the "County") has developed and received approval of a solid waste management plan (the "Plan") for the County pursuant to K.S.A. 65-3401 et seq. (the "Act"); and

WHEREAS, the Act allows the Board to provide for proper effective solid waste management and recycling systems by levying and collecting fees and charges upon persons receiving solid waste management system services; and

WHEREAS, the development and implementation of the Plan and of proper effective solid waste management and recycling systems requires funding which should be paid by a system of fees and charges as authorized by the Act.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS:

Section 1. Definitions. For purposes of this resolution, the following terms shall have the following meanings:

"Dwelling Unit" means a structure or the part of a structure that is used as a home, residence or sleeping place by one person who maintains a household or by two or more persons who maintain a common household.

"Nonresidential Improved Property" means a parcel of real property having a unique identifying number (Parcel Identification Number) on the property appraisal records of Sedgwick County, Kansas, on which no Dwelling Unit is constructed, and on which one or more structures other than a Dwelling Unit is constructed.

"Persons Receiving Service" as referred to in K.S.A. 65-3410 means, for the purposes of this resolution, all persons shown on the County's ad valorem tax records as owners of improved real property in the County, falling within the classifications set forth in this resolution.

"Residential Property" means a parcel of real property having a unique identifying number (Parcel Identification Number) on the property appraisal records of Sedgwick County, Kansas, on which at least one Dwelling Unit is constructed.

"Solid Waste Service Area" shall have the boundaries defined in Section 3 of this resolution.

All other words and phrases used in this resolution shall have the meanings defined in the Act, to the extent applicable.

- Section 2. Findings. The Board hereby finds and determines that:
- A. In order to develop and implement the Plan and to provide for proper effective solid waste management and recycling systems, it is desirable and necessary to establish, levy and collect fees and charges upon Persons Receiving Service in the Solid Waste Service Area.
- B. The most just, fair and equitable manner of imposing fees and charges is to divide the County's real property into certain classifications, so that the funds raised bear a reasonable relationship to the various uses to which the real property is put, the volume of waste occurring from the different land based classifications, the characteristics of waste generated from the different land uses and the services to be provided under the solid waste management and recycling systems.
- C. It is prudent and advisable, and in the best interests of the citizens of the County, to designate the entirety of the County, both incorporated and unincorporated, as the County's Solid Waste Service Area.
- Section 3. Designation of Solid Waste Service Area. The entirety of Sedgwick County, Kansas, both incorporated and unincorporated, is hereby designated as the County's Solid Waste Service Area.
- Section 4. Annual Fees. The following annual fees and charges are hereby imposed and levied upon all Persons Receiving Service and upon all Residential Property and Nonresidential Improved Property within the County's Solid Waste Service Area. Fees to be charged for each property within the various classifications and the classifications of real property within the County's Solid Waste Service Area are hereby determined as follows:
 - 1. Residential property, for each Dwelling Unit, \$6.48
 - 2. Nonresidential Improved Property, by land based classification standards as set forth in Exhibit A attached to this resolution:

Tier 1 -	\$4.46
Tier 2 -	\$5.94
Tier 3 -	\$7.43
Tier 4 -	\$8.91
Tier 5 -	\$5.94 x number of tenant spaces

Section 5. Basis for Determination of Fees. In establishing the fee schedule set forth in this resolution, the Board has considered the various uses to which real property designated within the schedule is put, the volume of solid waste occurring from the different land uses, the types of waste generated by the various classifications of real property within the schedule and the benefits to be received through the provision of solid waste services.

Section 6. Use of Fees Generated. All fees generated and collected pursuant to this resolution shall be used (a) for the development and management of solid waste processing, disposal services, and recycling programs (b) for development and operation of reclamation facilities and services for household hazardous materials within the solid waste service area and (c) to do all other things necessary for a proper effective solid waste system.

- Section 7. Collection of Fees. All fees implemented and established pursuant to this resolution shall be collected on a yearly basis by billing the fee on the ad valorem property tax statement issued to the owner of the affected property, or by separate billing where no separate ad valorem tax statement would be sent to the owner of the subject real property within the solid waste service area.
- Section 8. Collection of Delinquent Fees. Any fees implemented and charged pursuant to this resolution which remain unpaid for a period of 60 or more days after the date after which they were billed may be collected thereafter by the County in the following manner:
- (a) At least once a year, the Board shall cause to be prepared a report of delinquent fees. The Board shall fix a time, date and place for hearing the report and any objections or protests thereto.
- (b) The Board shall cause notice of the hearing to be mailed to the property owners listed on the report not less than ten days prior to the date of the hearing.
- (c) At the hearing, the Board shall hear any objections or protests of property owners liable to be assessed for delinquent fees. The Board may make such revisions or corrections to the report as it deems just, after which, by resolution, the report shall be confirmed.
- (d) The delinquent fees set forth in the report as confirmed shall constitute assessments against the respective parcels of land and are a lien on the property for the amount of such delinquent fees. A certified copy of the confirmed report shall be filed with the County Clerk for the amounts of the respective assessments against the respective parcels of land as they appear on the current assessment roll. The lien created attaches upon recording in the office of the County Clerk of a certified copy of the resolution of confirmation. The assessment may be collected at the same time and in the same manner as ordinary County ad valorem property taxes are collected and shall be subject to the same penalties in the same procedure and sale in case of delinquency as provided for such taxes. All laws applicable to the levy, collection and enforcement of County ad valorem property taxes shall be applicable to such assessment.

Section 9. Effective Date. The fees set forth in this resolution shall be effective from and after July 1, 2014. The billing for the fees shall be rendered with the ad valorem tax statements issued on or after November 1, 2014.
