

Tenaska Brownsville Partners, LLC, Tenaska Brownsville Generating Station Prevention of Significant Deterioration Permit for Greenhouse Gas Emissions PSD-TX-1350-GHG

Summary of Revisions in Final Permit

## I. Summary of the Formal Public Participation Process

The U.S. Environmental Protection Agency, Region 6 (EPA) proposed to issue a Prevention of Significant Deterioration (PSD) permit to Tenaska Brownsville Partners, LLC (Tenaska), Tenaska Brownsville Generating Station on October 29, 2014 and December 5, 2014. The public comment period on the draft permit began October 29, 2014 and closed on November 28, 2014. EPA announced the public comment period through a public notice published in the Brownsville Herald on October 29, 2014 and on Region 6's website. EPA also notified agencies and municipalities on October 28, 2014 in accordance with 40 CFR Part 124. A second comment period regarding EPA's obligations under the National Historic Preservation Act notifying the public of EPA's determination of adverse effect and a proposed draft Memorandum of Agreement (MOA) to address those adverse effects began on December 5, 2014 and closed on January 5, 2015. EPA announced the second public comment period through a public notice published in the Brownsville comment period through a public notice public comment period adverse effects began on December 5, 2014 and closed on January 5, 2015. EPA announced the second public comment period through a public notice published in the Brownsville Herald on Region 6's website.

The Administrative Record for the draft permit was made available at EPA Region 6's office. EPA also made the draft permit, statement of basis and other supporting documentation available on Region 6's website, and at the Brownsville Public Library, Brownsville, Texas. For the second public comment period, *EPA Adverse Effect Determination* and MOA was made available at EPA Region 6's office and website, and at the Brownsville Public Library, Brownsville, Texas.

EPA's public notice for the draft permit also provided the public with notice of the public hearing explaining that it was subject to cancellation if no requests for a hearing were received or if EPA determined that there was not a significant degree of public interest. EPA did not receive any written requests for a public hearing, and the public hearing arrangements were cancelled on November 21, 2014.

## **II. Revisions In Final Permit**
