The program offers an opportunity to explore various occupations within the agency as well as enrich your future career. You can join professional conservationists as they work directly with local farmers and ranchers in putting conservation practices on the land.

As an Earth Team volunteer on your way to becoming caretaker of natural re may find yourself help landowners prevent wind erosion, conserving and clead water, enhancing wildlife habitareducing flooding, or helping citizens of all ages learn about the environment and conservation through exciting educational activities.

The Earth Team offers outstanding and exciting opportunities for those who need professional work experience or academic credit. After serving on the Earth Team, you may decide to pursue a career in conservation.

ELIGIBILITY



You must be 14 years of age or older and interested in conserving natural resources. You can work part time or full time, outdoors or in a local NRCS office. You can volunteer as an individual or as a group.

STUDENT EDUCATIONAL EMPLOYMENT PROGRAMS





he Natural Resources
Conservation Service
(NRCS) employs students
from high schools, colleges, and
universities from around the
country, including Historically
Black Colleges and Universities,
Hispanic Association of Colleges
and Universities institutions, and
Native American Colleges and
Universities.

Students work in all areas of the Natural Resources Conservation Service: natural resources, agronomy, soil science, biology, wildlife, cultural resources, recreation, information resources, engineering and administration.

STUDENT CAREER EXPERIENCE PROGRAM (SCEP)

SCEP is a planned and progressive educational program that targets students from high school through graduate study. The program is designed to be a partnership between you, your school, and the Natural Resources Conservation Service. SCEP combines academic classroom learning with practical, on-the-job experience that provides you with a paid work experience in your field of study.

ELIGIBILITY

The program is open to half-time high school, undergraduate, and graduate college students (or students who have been accepted for enrollment) in accredited educational institutions. Students must be at least 16 years of age, maintain good academic standing, and be a U.S. citizen (or a permanent resident, provided that U.S. citizenship is achieved by the time of graduation).



WORK PERIODS

There are many ways to work in the career experience program. Some schedules may alternate full-time semesters or quarters of study. Others may provide for part-time work with parallel periods of study. The Natural Resources Conservation Service offices, schools, and students design schedules that work best for them.

PAY AND BENEFITS

As a SCEP student, you start earning a salary from the first day. Your initial rate of pay will depend upon your education and work experience. As you advance in responsibility, your pay will reflect your talents and contributions.

As a SCEP student, you will receive benefits right from the start. The benefits you are automatically eligible for are:

- Paid vacation days, holidays, and sick leave;
- Health and life insurance;
 and
- Retirement/investment plans

You may also be eligible for training and tuition assistance.

Conversion To Permanent Employment

Upon successful completion of all your work study and degree requirements, you will be eligible to be converted noncompetitively to a permanent position within the competitive service within 120 calendar days of graduation.



HOW CAN YOU APPLY FOR THIS Program?

Students may apply through their school's cooperative education placement office or directly to the Natural Resources
Conservation Service, Human
Resources office listed. All applicants must include a transcript of grades along with an OF-612, Optional Application for Federal Employment, or a resume.

STUDENT TEMPORARY EMPLOYMENT PROGRAM (STEP)

STEP provides temporary Federal employment to qualified students. Student positions are covered by one-year renewable appointments. The duties do not have to relate to your academic career goals.

ELIGIBILITY

You are eligible for a STEP appointment if you are:

- •Enrolled as a half-time student (or have been accepted for enrollment) in an accredited high school; vocational school; or associate degree, baccalaureate, or graduate program
- •Working toward a diploma, certificate, or degree



- Maintaining a satisfactory academic record
- •At least 16 years of age at the time of appointment; and
- A U.S. citizen

PAY AND BENEFITS

As a STEP participant, your rate of pay will depend upon your current education, work experience, and other position requirements. As you advance, you will be eligible for promotions, awards, and other pay increases. You will also be entitled to other benefits, including paid vacation days, holidays, and sick leave.

HOW CAN YOU APPLY FOR THIS PROGRAM?

The Natural Resources
Conservation Service recruits
candidates directly from schools or
through local State Employment or
Job Service Offices. You can
contact your school or the offices
mentioned above and they will
assist you in getting started.
