Please provide all detained Haitian nationals (or those who last habitually resided in Haiti), to include those currently detained and those entering custody, a copy of the Secretary's press release and the Federal Register notice (attached).

Please ensure the attached is issued without regard to a particular alien's perceived ineligibility, (i.e. provide a copy of all documents and applications even if you believe the alien would not otherwise qualify).

Any Haitian national who expresses a desire to apply for TPS must be provided forms I-821 and I-765 (attached) and accompanying instructions. Guidance documents are also available here in French and Haitian Creole for those not proficient in English.

Please have the above request completed by 5:00 pm EST on February 1, 2010. Each Field Office should send an email to DDO [REDACTED] b6, b7c at [REDACTED] b6, b7c certifying compliance with the above request. # **Statement from Homeland Security Secretary Janet Napolitano on Temporary Protected Status (TPS) for Haitian Nationals**

"As part of the Department's ongoing efforts to assist Haiti following Tuesday's devastating earthquake, I am announcing the designation of Temporary Protected Status (TPS) for Haitian nationals who were in the United States as of January 12, 2010. This is a disaster of historic proportions and this designation will allow eligible Haitian nationals in the United States to continue living and working in our country for the next 18 months. Providing a temporary refuge for Haitian nationals who are currently in the United States and whose personal safety would be endangered by returning to Haiti is part of this Administration's continuing efforts to support Haiti's recovery."

"At this moment of tragedy in Haiti it is tempting for people suffering in the aftermath of the earthquake to seek refuge elsewhere. But attempting to leave Haiti now will only bring more hardship to the Haitian people and nation. The international community has rallied to deliver relief to Haiti. Much has already arrived and much more is on its way. The Haitians are resilient and determined and their role in addressing this crisis in their homeland will be essential to Haiti's future."

"It is important to note that TPS will apply only to those individuals who were in the United States as of January 12, 2010. Those who attempt to travel to the United States after January 12, 2010 will not be eligible for TPS and will be repatriated."

"The Department of Homeland Security continues to extend sympathy to our Haitian neighbors and support the worldwide relief effort underway in every way we can. Four Coast Guard cutters have arrived in Haiti, in addition to a variety of Coast Guard assets that were already in the area to support military air traffic control, conduct damage assessments and rescue people in need of assistance. The Federal Emergency Management Agency (FEMA) continues to work closely with the U.S. Agency for International Development (USAID) and the State Department - the lead U.S. federal agencies in the response - while coordinating the deployment of state and local Urban Search and Rescue Teams from across the country to Haiti and standing by to provide food, water and other resources as requested. U.S. Customs and Border Protection (CBP) has provided aircraft to support response efforts."

#### Designation of Haiti for Temporary Protected Status

**AGENCY:** U.S. Citizenship and Immigration Services, DHS.

**ACTION:** Notice.

**SUMMARY:** The Department of Homeland Security announces that the Secretary of Homeland Security (Secretary) has designated Haiti for temporary protected status (TPS) for a period of 18 months. Under section 244(b)(1) of the Immigration and Nationality Act, the Secretary is authorized to designate a foreign state for TPS or parts of such state upon finding that such state is experiencing ongoing armed conflict, an environmental disaster, or "extraordinary and temporary conditions." The Secretary may grant TPS to individual nationals of the designated foreign state (or to eligible aliens having no nationality who last habitually resided in such state) who have been both continuously physically present in the United States since the effective date of the designation and continually residing in the United States since a date determined by the Secretary, and who meet other eligibility criteria. TPS is available only to persons who were continuously physically present in the United States as of the effective date of the designation.

Under this designation, Haitian nationals (and aliens having no nationality who last habitually resided in Haiti) who have continuously resided in the United States since January 12, 2010, and who remain in continual physical presence in the United States from the effective date of the notice, may apply for TPS within the 180-day registration period that begins on the date of publication of the notice. These nationals also may apply for employment authorization documents and for permission to depart from and return to the United States.

This notice also sets forth procedures necessary for nationals of Haiti (or aliens having no nationality who last habitually resided in Haiti) to register and to apply for TPS and employment authorization documents with U.S. Citizenship and Immigration Services.

**DATES:** This designation of Haiti for TPS is effective on January 21, 2010, and will remain in effect through July 22, 2011. The 180-day registration period for eligible individuals to submit their TPS applications begins January 21, 2010, and will remain in effect until July 20, 2010.

##### What Is Temporary Protected Status?

TPS is a temporary immigration status granted to eligible nationals of a country (or to persons without nationality who last habitually resided in the designated country) that the Secretary has designated for TPS because the country is experiencing an ongoing armed conflict, an environmental disaster, or extraordinary and temporary conditions. During the period for which the Secretary has designated a country for TPS, TPS beneficiaries are eligible to remain in the United States and may

obtain work authorization, so long as they continue to meet the terms and conditions of their TPS status. The granting of TPS is available only to persons who were continuously physically present in the United States as of the effective date of this designation and does not lead to permanent resident status.

When the Secretary terminates a country's TPS designation, beneficiaries return to the same immigration status they maintained before TPS (unless that status has since expired or been terminated) or to any other status they may have obtained while registered for TPS.

#### What Authority Does the Secretary of Homeland Security Have To Designate Haiti for TPS?

The Immigration and Nationality Act (INA), authorizes the Secretary, after consultation with appropriate agencies of the government, to designate a foreign State (or part thereof) for TPS.<sup>1</sup> One of the bases for TPS designation is "there exist extraordinary and temporary conditions in the foreign state that prevent aliens who are nationals of the state from returning to the state in safety, *unless* [she] finds that permitting the aliens to remain temporarily in the United States is contrary to the national interest of the United States." INA section 244(b)(1)(C) (emphasis added); 8 U.S.C. 1254a(b)(1)(C). The Secretary has determined, after consulting with the Department of State (DOS) and other government agencies, that there exists in Haiti "extraordinary and temporary conditions," preventing Haitian nationals from returning to Haiti in safety and that permitting eligible Haitian nationals to remain temporarily in the United States would not be contrary to the national interest.

Following the designation of a country for TPS, the Secretary may grant TPS to eligible nationals of that foreign State (or aliens having no nationality who last habitually resided in that State) who have been both continually physically present in the United States since the effective date of the notice and continually residing in the United States since a date determined by the Secretary, and who meet all other eligibility criteria. INA section 244(a)(1)(A) and (c); 8 U.S.C.

1254a(a)(1)(A) and (c). Persons convicted of any felony, or two or more misdemeanors, committed in the United States are ineligible for TPS. Applicants may also be ineligible if one of the bars to asylum eligibility applies. *Id.* at section 244(c)(2)(B)(i–ii).

#### Why Is the Secretary Designating Haiti for TPS?

On January 12, 2010, Haiti was struck by a 7.0-magnitude earthquake. DHS and DOS have conducted an initial review of the conditions in Haiti following the earthquake. Based on this review, the Secretary has determined to designate Haiti for TPS for 18-months pursuant to section 244(b)(1)(C) of the INA for reasons discussed below. The Department of State concurs in the designation of Haiti for a period of 18 months.

The epicenter of the earthquake was off the coast of Haiti, and only 17 km from the capital, Port-au-Prince, an area where some three million of the nation's nine million residents reside. Aftershocks have been measured at 5.9 and 5.5 respectively, and more aftershocks are expected.

Reports indicate that the earthquake destroyed most of the capital city. Initial estimates indicate that the death toll is substantial. The International Red Cross indicates that about three million people—one-third of Haiti's population—have been affected by the earthquake.

Reports also indicate that concrete homes have collapsed and hospitals are overflowing with victims. The Presidential Palace, the Ministry of Justice, Parliament, the tax office and other government buildings, as well as the United Nations headquarters, and the World Bank offices are among the buildings reported to be destroyed or damaged. Hospitals and schools have been destroyed. The Ministry of Public Works and the Ministry of Communication and Culture have also been damaged.

The country's critical infrastructure, including its capacity for the provision of electricity, water, and telephone services, has been severely affected. Food and water are increasingly scarce. Fuel shortages are emerging as an immediate concern.

There is limited access to the capital city. Roads are blocked by debris and other obstacles, and the collapse of the Croix de Mission Bridge has cut off a major artery between Port-au-Prince and the northern part of the country, making it more difficult to transport food, fresh water, and medical supplies. Haiti's main airport in Port-au-Prince, Toussaint L'Ouverture International

Airport, also has suffered significant damage that is hindering access to the country.

Haiti has limited resources to cope with a natural disaster, and now has been struck by its strongest earthquake in 200 years. Although a number of organizations and countries have pledged humanitarian aid, the magnitude of the disaster is substantial.

Given the size of the destruction and humanitarian challenges, there clearly exist extraordinary and temporary conditions preventing Haitian nationals from returning to Haiti in safety. Moreover, allowing eligible Haitian nationals to remain temporarily in the United States, as an important complement to the U.S. government's wider disaster relief and humanitarian aid response underway on the ground in Haiti, would not be contrary to the public interest.

DHS estimates that there are 100,000 to 200,000 nationals of Haiti (or otherwise eligible aliens having no nationality who last habitually resided in Haiti) who are eligible for TPS under this designation.

#### Designation of Haiti for TPS

Based upon these unique, specific, and extreme factors, the Secretary has determined, after consultation with the appropriate Government agencies, that there exist extraordinary and temporary conditions in Haiti preventing aliens who are nationals of Haiti from returning to Haiti in safety. The Secretary further finds that it is not contrary to the national interest of the United States to permit Haitian nationals (or aliens having no nationality who last habitually resided in Haiti) who meet the eligibility requirements of TPS to remain in the United States temporarily. See INA section 244(b)(1)(C); 8 U.S.C. 1254a(b)(1)(C). On the basis of these findings and determinations, the Secretary concludes that Haiti should be designated for TPS for an 18-month period. See INA section 244(b)(2)(B); 8 U.S.C. 1254a(b)(2)(B).

Nationals of Haiti (and aliens having no nationality who last habitually resided in Haiti) who have been "continuously physically present" in the United States since January 21, 2010 and have "continuously resided" in the United States since January 12, 2010, may apply for TPS within the registration period that begins on January 21, 2010 and ends on July 20, 2010. Except as specifically provided in this notice, applications for TPS by nationals of Haiti (and aliens having no nationality who last habitually resided in Haiti) must be filed pursuant to the

provisions of 8 CFR part 244. Aliens who wish to apply for TPS must file an Application for Temporary Protected Status, Form I-821, together with an Application for Employment Authorization, Form I-765, in accordance with the form's instructions and applicable regulations during the registration period.

**Required Application Forms and Application Fees To Register for TPS**

To register for TPS, an applicant must submit two applications:

1. Form I-821, Application for Temporary Protected Status, and pay the Form I-821 application fee, which is \$50. If you are unable to pay the fee, you

may submit a fee waiver request with appropriate documentation.

2. Form I-765, Application for Employment Authorization.

- If you want an employment authorization document (EAD), you must pay the Form I-765 application fee, which is \$340, or submit a fee waiver request.
- However, if you are filing an initial TPS registration and you are under the age of 14 or above the age of 65, you do not pay the Form I-765 fee to obtain an EAD.

- If you are not requesting an EAD, you do not pay the Form I-765 fee.

3. Individuals who may apply for TPS pursuant to this notice and who are in removal proceedings will be provided an opportunity to apply in accordance with 8 CFR 244.7(d).

You must submit both applications together. For more information on the application forms and application fees for TPS, please visit the USCIS Web site at <http://www.uscis.gov>.

**Biometric Services Fee**

Biometrics (such as fingerprints) are required for all applicants 14 years of age or older. Those applicants must submit a biometric services fee of \$80. If you are unable to pay the fee, you may submit a fee waiver request with appropriate documentation. **E-Filing**

You cannot E-file your application when applying for initial registration for TPS. Please mail your application to the mailing address listed in Table 3 above.

**Supporting Documents**

*What type of basic supporting documentation must I submit?*

To meet the basic eligibility requirements for TPS, you must submit evidence that you:

- Are a national of Haiti or an alien of no nationality who last habitually resided in Haiti (such as a copy of your passport, birth certificate with English translation, etc.);
- Continually resided in the United States since January 12, 2010 (see 8 CFR 244.9(a)(2));
- Have been continually physically present in the United States since January 21, 2010; and
- Two color passport-style photographs of yourself.

The filing instructions on Form I-821, Application for Temporary Protected Status, list all the documents needed to establish basic eligibility for TPS.

*Do I need to submit additional supporting documentation?*

If one or more of the questions listed in Part 4, Question 2 of the Form I-821 applies to you, then you must submit an explanation on a separate sheet(s) of paper, and/or additional documentation. Depending on the nature of the question(s) you are addressing, additional documentation alone may suffice, but usually a written explanation will also be needed.

**Employment Authorization Document (EAD)**

*May I request an interim EAD at my local USCIS office?*

No. USCIS will not issue interim EADs to TPS applicants at USCIS local offices.

*What documents may a qualified individual show to his or her employer as proof of employment authorization and identity when completing Form I-9, Employment Eligibility Verification?*

TPS beneficiaries under the designation of Haiti who have timely registered with USCIS as directed under this Notice and obtained an EAD, may present their valid EAD to their employers as proof of employment

authorization and identity. Employers may not accept EADs that are no longer valid.

Individuals may also present any other legally acceptable document or combination of documents listed on the Form I-9 as proof of identity and employment eligibility.

**Note to Employers**

Employers are reminded that the laws requiring employment eligibility verification and prohibiting unfair immigration-related employment practices remain in full force. This notice does not supersede or in any way limit applicable employment verification rules and policy guidance, including those rules setting forth re-verification requirements. In compliance with the requirements of Section 202(c)(5), this notice advises of actions that have been taken by the Board from July 10, 2008 to August 4, 2009.

### I. Settlement Agreements, Civil Money Penalties, Withdrawal of FHA Approval, Suspensions, Probations, Reinstatement and Reprimand

#### 1. *Ascella Mortgage, LLC, Manchester, CT* [Docket No. 09-9610-MR]

**Action:** On August 4, 2009, the Board voted to immediately withdraw Ascella Mortgage LLC's (Ascella) FHA approval for a period of one year.

**Cause:** The Board took this action based on the following violation of HUD/FHA requirements alleged by HUD: Ascella failed to notify HUD that

it voluntarily surrendered its license to originate mortgages.

#### 2. *Americare Investment Group, Inc. d/b/a/Premiere Capital Lending, Arlington, TX* [Docket No. 08-8082-MR]

**Action:** On October 8, 2009, the Board entered into a settlement with Americare Investment Group, Inc.'s, d/b/a Premiere Capital Lending (Americare) requiring, without the admission of fault or liability, the payment of a civil money penalty of \$124,000 and placing Americare on probation for a period of six months. During the period of probation, Americare will be required to obtain and provide to HUD post-closing reviews on all construction-to-permanent loans closed during the period.

**Cause:** The Board took this action based on the following violations of HUD/FHA requirements alleged by HUD: (1) Failing to include required loan documents and information and (2) failing to ensure that the maximum mortgage amount was properly calculated, resulting in over-insured mortgages.

#### 3. *Beneficial Mortgage Corp., San Juan, PR* [Docket No. 09-9626-MR]

**Action:** On June 3, 2009, the Board immediately suspended Beneficial Mortgage's (Beneficial) FHA approval pending the outcome of a HUD review and any ensuing legal proceedings.

**Cause:** The Board took this action based on the following violation of HUD/FHA requirements alleged by HUD: Beneficial failed to notify HUD of a business change affecting the information upon which Beneficial was originally approved. Specifically, Beneficial failed to notify HUD that it was the subject of an investigation by the Puerto Rico Financial Institutions Commissioner's Office.

#### 4. *Community Home Lending, Inc., Birmingham, AL* [Docket No. 09-8041-MR]

**Action:** On July 1, 2009, the Board entered into a settlement agreement with Community Home Lending, Inc.'s (Community) requiring Community to pay a civil money penalty in the amount of \$11,500 without admitting fault or liability.

**Cause:** The Board took this action based on the following violations of HUD/FHA requirements alleged by HUD: Community violated third party origination restrictions by allowing non-employees to originate FHA-insured mortgages; allowed an employee to originate FHA-insured mortgages and simultaneously work in the fields of

property management and real estate; failed to maintain a quality control (QC) plan conforming to all HUD/FHA requirements, including allowing its reviews to be conducted by a loan officer; and failing to conduct QC reviews in 15 early default cases.

#### 5. *Eagle Nationwide Mortgage Company, Chadds Ford, PA* [Docket No. 09-9003-MR]

**Action:** On July 29, 2009, the Board entered into a settlement agreement with Eagle Nationwide Mortgage Company's (Eagle) requiring Eagle to pay a \$3,500 civil money penalty without admitting fault or liability.

**Cause:** The Board took this action based on the following violations of HUD/FHA requirements alleged by HUD: Eagle distributed a direct mail solicitation which improperly used the name of the Federal Housing Administration, thereby implying FHA endorsement of Eagle's programs. Additionally, the text of the advertisement implied that Eagle employed FHA personnel.

#### 6. *Golden First Mortgage Corp., Great Neck, New York* [Docket No. 09-9625-MR]

**Action:** On June 3, 2009, the Board immediately suspended Golden First Mortgage's (Golden First) FHA approval pending the outcome of the Office of Inspector General's investigation and any ensuing legal proceedings.

**Cause:** The Board took this action based on the following violations of HUD/FHA requirements alleged by HUD: Golden First failed to notify HUD of a business change affecting the information upon which Golden First was originally approved. Specifically, Golden First Mortgage failed to notify HUD that its president was under investigation by the Office of Thrift Supervision, U.S. Department of Treasury, and was a party to a civil money penalty proceeding.

#### 7. *Great Country Mortgage Bankers, Corp., Coral Gables, FL* [Docket No. 09-9618-MR]

**Action:** On June 3, 2009, the Board immediately suspended Great Country Mortgage Bankers Corporation's (Great Country) FHA approval pending the outcome of a HUD review and any ensuing legal proceedings.

**Cause:** The Board took this action based on the following violations of HUD/FHA requirements alleged by HUD: Great Country failed to implement a QC plan in compliance with HUD/FHA requirements by failing to conduct QC reviews on loans defaulting within six months of origination; failed to

#### 1. Who May File for TPS?

You must be an eligible national of a foreign state (or parts thereof) or an alien having no nationality who last habitually resided in a foreign state that has been designated for Temporary Protected Status (TPS) by the Secretary of the Department of Homeland Security pursuant to section 244A of the Immigration and Nationality Act. You should check with the nearest office of USCIS for designations currently in force or visit our website at [www.uscis.gov](http://www.uscis.gov).

#### 2. What Documents Should You Submit?

*You do not need to provide original documents with this application.*

You must give USCIS copies of documents to prove you are a national of the country designated for TPS, your date of entry into the United States, and your U.S. residence. In addition:

- A. In certain circumstances, USCIS may ask you to submit original documents.
- B. Copies of documents in a foreign language must be accompanied by an English translation. The translator must certify that the translation is accurate and that he or she is competent to translate the foreign language into English.

**NOTE:** In all of these documents, your name and the name of the employer or other interested organization must appear on the form or letter, as well as relevant dates. Letters from employers must be in affidavit form and shall be signed and attested to by the employer under penalty of perjury.

Such letters must include: (1) your address(es) at the time of employment; (2) exact period(s) of employment; (3) period(s) of layoff; (4) duties with the company. If the employment records are unavailable, submit an affidavit form letter explaining why these records cannot be obtained. This affidavit form letter shall be signed and attested to by the employer under penalty of perjury.

- B. Rent receipts, utility bills (gas, electric, phone, etc.), receipts, or letters from companies showing the dates during which you received service.
- C. School records (letters, report cards, etc.) from the schools that you or your children have attended in the United States, showing the name(s) of the schools and periods of school attendance.
- D. Hospital or medical records concerning treatment or hospitalization of you or your children, showing the name of the medical facility or physician and the date(s) of the treatment or hospitalization.
- E. Attestations by churches, unions, or other organizations to your residence identifying you by name. The attestation must be signed by an official (whose title is shown); show inclusive dates of membership; state the

address where you resided during membership period(s); include the seal of the organization impressed on the letter or the letterhead of the organization, if the organization has letterhead stationery; establish how the author knows you; and establish the origin of the information being attested to.

- F. Additional documents may include money order receipts for money sent in or out of the country; passport entries; birth certificates of children born in the United States; dated bank transactions; correspondence between you and another person or organization; U.S. Social Security card; Selective Service card; automobile license receipts, title, vehicle registration, etc.; deeds, mortgages, contracts to which you have been a party; tax receipts; insurance policies; receipts; letters; or
- G. Any other relevant document.

#### 6. What If Documents Are Not Available?

**Subject:** Review of Haitian nationals currently detained for possible release on an Order of Supervision or Order of Own Recognizance

On January 12, 2010, a 7.0 magnitude earthquake in Haiti resulted in the loss of many lives and significant damage to infrastructure. On January 15, 2010, Department of Homeland Security Secretary Janet Napolitano announced the designation of Temporary Protected Status (TPS) for Haitian nationals who were in the United States as of January 12, 2010. As the attached document titled "Haiti Release Paper" explains, the Office of Detention and Removal Operations (DRO) has been asked to review the custodial status of its detained Haitian population and assess whether or not further custody of those individuals remains warranted.

In light of the possibility of TPS for some Haitians currently in ICE custody, field offices must review the cases in their area of responsibility and consider whether release is appropriate. As a general matter, Haitian nationals who are not precluded from qualifying for TPS as a result of criminal convictions or other factors should be released from custody, absent a national security risk, history of human rights violations, danger to the community, gang affiliation, medical or mental health conditions affecting the viability of release, and any other such relevant factors.

Similarly, Haitian nationals who appear to be eligible for TPS should not be supervised pursuant to the Alternatives to Detention (ATD) program. In addition, non-detained, non-criminal, and non-dangerous Haitian nationals who appear to be eligible for TPS and are currently supervised on forms of ATD should no longer be supervised through the ATD program. However, officers shall take steps to ensure awareness of the addresses and intended residences of all Haitian nationals granted TPS in order to enforce any final orders of removal when the TPS period expires.

Given the operational impediments to releasing all TPS-eligible Haitian nationals at once, ICE will prioritize the release of Haitian nationals in the first category below, followed by Haitian nationals in the second and third categories.

1. Non-criminal Haitian nationals who are subject to final orders of removal—with priority to those with the longest length of stay in ICE custody, to include those cases still in the statutory “removal period.” However, any individuals in this category who have been found either inadmissible under section 212(a)(3)(B) of the Immigration and Nationality Act (INA) or deportable under INA § 237(a)(4)(B) shall not be released under this guidance.
2. Non-criminal Haitian nationals who are not subject to final orders of removal—with priority to those with the longest length of stay in ICE custody. However, any individuals subject to mandatory detention under INA § 236(c) for having committed but not convicted of certain offenses should not be released pursuant to this guidance. Additionally, cases described in INA §§ 212(a)(3) and 237 (a)(4) shall not be released under this guidance.
3. Haitian nationals with criminal convictions that do not render them statutorily ineligible for TPS. However, any individuals subject to mandatory detention under INA § 236(c) for having committed but not convicted of certain offenses should not be released pursuant to this guidance. Additionally, cases described in INA §§ 212(a)(3) and 237 (a)(4) shall not be released under this guidance.

While not an exclusive list, the following key factors must be considered when making release decisions:

- A) Whether the individuals pose a threat to themselves and/or the community, such as gang affiliation, human rights violators, and violent offenders;
- B) Whether the individual has any medical issues or concerns for him/herself or immediate family members;
- C) Whether the individual has family ties and support in the United States;
- D) Whether the individual has a last known address and/or likely abode upon release; and
- E) Whether the individual has any equities in the United States, including, but not limited to, property ownership and eligibility for employment.

According to ICE records, as of January 19, 2010, attached is a list of all 487 detained Haitian nationals. The Administrative file (A-File) for each case must be reviewed, as EARM may not be updated to include an individual’s criminal charge(s) and final order date. DRO field offices must conduct their individual case reviews in consultation with the local Offices of Chief Counsel (OCC) and work together to assess whether Haitian nationals in custody are statutorily eligible for TPS and for release. Criminal Haitian nationals eligible for release will be subject to placement into an Alternatives to Detention (ATD) program in accordance with current ATD guidance regarding placement, enrollment, and the type and level of supervision imposed. Non-criminal Haitian nationals will not be placed into an ATD program.

Until further notice, the above-referenced factors (labeled A-E) should be considered when making initial custody determinations for any new Haitian nationals who are placed into removal proceedings and have established a prima facie eligibility for TPS. Accordingly, the detention priorities for any Haitian nationals who arrived prior to January 12, 2010 and are initially encountered after this guidance is disseminated should be handled in the reverse order. As such, DRO would prioritize the detention of criminal Haitian nationals who do not have final orders of removal first. Non-criminal Haitian nationals who are subject to final orders of removal (absent any mandatory detention requirements) would be prioritized last. In the event of a mass migration declaration made by the President of the United States, Haitian nationals encountered after the date of the formal declaration shall be detained until removed.

ICE will detain and pursue the removal of any Haitian nationals who arrive in the United States after January 12, 2010, without lawful authority to enter or remain in the United States; and ICE will continue to detain and pursue the removal of Haitian nationals who are ineligible for TPS—recognizing the need to work closely with the Government of Haiti and likelihood of logistical impediments in the near term. If these impediments remain, additional guidance will be issued.

This policy and statement of priorities and the decisions made as a result are not intended to, do not, and may not be relied upon to create any right or benefit, substantive or procedural, enforceable at law by any party in any administrative, civil, or criminal matter.

## U.S. Immigration and Customs Enforcement

### Reevaluating the Custody Status of Haitian Nationals

On January 12, 2010, a 7.0 magnitude earthquake in Haiti resulted in the loss of many lives and significant damage to infrastructure. As a result, on January 13, 2010, ICE temporarily suspended all removals to Haiti.<sup>1</sup> On January 15, 2010, Secretary Napolitano announced the designation of Temporary Protected Status (TPS) for Haitian nationals who were in the United States as of January 12, 2010.

ICE will detain and pursue removal of Haitian nationals who arrive after January 12, 2010, and lack lawful status. In addition, ICE will reevaluate the custody status of Haitian nationals who are likely eligible for TPS and resume removals of Haitian nationals who are ineligible for TPS—recognizing the need to work closely with the Government of Haiti and likelihood of logistical impediments in the near term. In the event the logistical impediments remain for an extended period, additional guidance will be issued.

#### **I. Reevaluating the Custody Status of Haitian Nationals**

As of January 11, 2010, 528 Haitian nationals were in ICE custody, including 124 criminal aliens and 36 non-criminal aliens with final orders and 294 criminals and 74 non-criminal aliens not subject to a final order and in some form of proceeding. Additional information about the population of Haitian nationals in detention follows in Appendix A. In light of the possibility of TPS for some Haitians currently in our custody, field offices must review the cases in their area of responsibility and consider whether release is appropriate.

As a general matter, Haitian nationals who are not precluded from qualifying for TPS as a result of criminal convictions or other factors should be released from custody, absent a national security risk, history of human rights violations, danger to the community, gang affiliation, medical or mental health conditions affecting the viability of release, and any other such relevant factors. Similarly, Haitian nationals who appear to be eligible for TPS should not be supervised pursuant to the Alternatives to Detention (ATD) program. In addition, non-detained, non-criminal, and non-dangerous Haitian nationals who appear to be eligible for TPS and are currently supervised on forms of ATD should no longer be supervised through the ATD program. However, officers shall take steps to ensure awareness of the addresses and intended residences of all Haitian nationals granted TPS in order to enforce any final orders of removal when the TPS period expires.

Given the operational impediments to releasing all TPS-eligible Haitian nationals at once, ICE will prioritize the release of Haitian nationals in the first category below, followed by Haitian nationals in the second and third categories.

<sup>1</sup>During August and September of 2008, Hurricanes Gustav and Ike struck Haiti. Following those hurricanes, removals to Haiti slowed substantially and almost exclusively involved Haitians with criminal convictions.

1. Non-criminal Haitian nationals who are subject to final orders of removal—with priority to those with the longest length of stay in ICE custody, to include those cases still in the statutory “removal period.” However, any individuals in this category who have been found either inadmissible under section 212(a)(3)(B) of the Immigration and Nationality Act (INA) or deportable under INA § 237(a)(4)(B) shall not be released under this guidance.
2. Non-criminal Haitian nationals who are not subject to final orders of removal—with priority to those with the longest length of stay in ICE custody. However, any individuals subject to mandatory detention under INA § 236(c) for having committed but not convicted of certain offenses should not be released pursuant to this guidance. Additionally, cases described in INA §§ 212(a)(3) and 237 (a)(4) shall not be released under this guidance.
3. Haitian nationals with criminal convictions that do not render them statutorily ineligible for TPS. However, any individuals subject to mandatory detention under INA § 236(c) for having committed but not convicted of certain offenses should not be released pursuant to this guidance. Additionally, cases described in INA §§ 212(a)(3) and 237 (a)(4) shall not be released under this guidance.

The review of cases of all Haitian nationals in custody shall be completed within two weeks. DRO and the Office of Chief Counsel (OCC) must work together to assess whether Haitian nationals in custody are statutorily eligible for TPS and for release. In the event logistical impediments prevent the removal of detained Haitians who are not eligible for TPS, the field will receive additional guidance.

This policy and statement of priorities and the decisions made as a result are not intended to, do not, and may not be relied upon to create any right or benefit, substantive or procedural, enforceable at law by any party in any administrative, civil, or criminal matter.

## **II. Detention and Removal of Haitian Nationals who Arrive in the United States after January 12, 2010**

ICE will detain and pursue the removal of any Haitian nationals who arrive in the United States after January 12, 2010, without lawful authority to enter or remain in the United States.

## **III. Detention and Removal of Haitian Nationals Ineligible for TPS**

ICE will continue to detain and remove Haitian nationals who are ineligible for TPS—recognizing the need to work closely with the Government of Haiti and likelihood of logistical impediments in the near term. If these impediments remain, additional guidance will be issued. DRO and OCC must work closely together on all post-order custody reviews.
