**I. General**1. Scope of work

Furnish all materials, equipment and labor for the demolition and replacement of one (1) garage concrete apron at Otter Brook Lake and one (1) garage concrete apron at Surry Mountain Lake.

2. Location

The Surry Mountain Lake Project Office is located at 108 Surry Dam Rd. Surry, NH 03431. The Otter Brook Lake office is located at 480 Branch Road, Keene, NH 03431.

3. Site Visit

Contact the Technical Point of Contact to arrange a site visit. The Technical Point of Contact for the project is, John Asseng, (603) 352-4130 or [John.e.asseng@usace.army.mil](mailto:John.e.asseng@usace.army.mil).

4. Schedule

The period of performance shall be 90 days from Contract Award. Work shall be scheduled Monday through Friday between 7:00 AM to 3:30 PM and the schedule must be submitted to, and approved by the Technical Point of Contact, in advance. All work must be conducted during the approved schedule hours unless additional hours are approved by the Technical Point of Contact. No work shall be conducted on weekends or Government holidays.

5. Safety

The contractor will comply with all pertinent provisions of the latest edition of the *U.S. Army Corps of Engineers Safety and Health Requirements* COE EM 385-1-1. A copy of COE EM 385-1-1 is available for reference at the project office or the manual may be viewed at the following link:

The contractor shall also comply with all OSHA work safety standards. The project staff can and will order the cessation of work at any time should the safety of employees and visitors become jeopardized.

6. Preconstruction Conference

Prior to the start of any work, the Technical Point of Contact will schedule and conduct a "Preconstruction Conference". The Contractor's Project Manager and Quality Control

Personnel will attend this meeting. This conference will be held at the time and location agreeable to the government and contractor. No work may be performed under this contract prior to this conference. The purpose of the conference is to enable the Technical Point of Contact to outline the procedures that will be followed by the Government in its administration of the contract, and to discuss the performance that will be expected from the Contractor. This conference will allow the Contractor an opportunity to ask questions about the Government's administration and inspection of contract work or obtain other pertinent information that might be required. At the Preconstruction conference the contractor shall provide the name of the project superintendent with a telephone number for project coordination.

The following is a general list of items for discussion during this Preconstruction Conference:

- i. Authority of the Technical Point of Contact and Quality Assurance Inspectors.
- ii. Three Phase Control System
- iii. Contractor's Safety Program (including sub-contractors).
- iv. Modified Activity Hazard Analysis (Submitted & accepted prior to start of work on site)

7. Permits

The Contractor shall, without additional expense to the Government, be responsible for obtaining any necessary licenses, permits, and letters of certification. The Contractor shall comply with any applicable Federal, State, County, and Municipal laws, codes, and regulations in connection with the performance of the work specified under this contract.

8. Security

The contractor will comply with all established security policies at Surry Mountain and Otter Brook Lakes. Due to periods of heightened security that may affect the access to the areas covered under this contract, areas may be subject to periodic closures, which in turn may reduce or inhibit the Contractor's ability to access certain areas. During periods of heightened security, the Government reserves the right, at any time, to close any property or portion of property and reschedule and/or cancel any subsequent service in an area. The Contractor shall be given at least 24 hour notice of any such closure.

9. Contractor Conduct

Alcohol and firearms are prohibited on project grounds. Contractor and employees must comply with CFR Title 36 Rules and Regulations.

10. Payment

Payment shall be made on a per job basis. After final inspection and acceptance by the

Government, the Contractor must submit an invoice to the Technical Point of Contact. The invoice shall include the invoice date, contract number, dates of service, description of work, quantities, process, and total amount due per line item. For jobs greater than 30 days the contractor may request progress payment.

**II. Technical Requirements:****Part 1 General:****Summary:**

Furnish all materials, equipment and labor for the demolition and replacement of two (2) concrete aprons. One apron is approximately 56 (fifty six) feet long, by 6 (six) feet, 6 (six) inches wide, by six (6) inches deep and located at Surry Mountain Dam, Surry, New Hampshire. The second apron is approximately 45 (forty five) feet long, by 6 (six) feet 6 (six) inches wide, by 6 (six) inches deep, and located at Otter Brook Lake, Keene, NH. Replacement shall be conducted in accordance with the products manufacture's recommendations, applicable regulations and listed references.

**Existing Conditions:**

Surry Mountain Lake has a concrete apron measuring approximately 56 (fifty six) feet by 6 (six) feet 6 (six) inches wide by 6 (six) inches deep. The concrete aprons abut to the concrete garage floors and are separated by angle iron imbedded into the garage floor opening. Assumption should be made that there is reinforcement rod imbedded in the concrete aprons. (See informational photos 1-3).

Otter Brook Lake has a concrete apron measuring approximately 45 (forty five) feet by 6 (six) feet, 6 (six) inches wide by 6 (six) inches deep. The concrete aprons abut to the concrete garage floors and are separated by angle iron imbedded into the garage floor opening. Assumption should be made that there is reinforcement rod imbedded in the concrete aprons. (See informational photos 4-6).

**Submittals:**

Although the Government technically reviews submissions required by this scope of work, it is emphasized that the Contractor's work must be prosecuted using proper internal controls and review procedures. The documents identified below must be prepared in accordance with the applicable standards, submitted for review and accepted by the government prior to the commencement of any field activities.

**Clean Up:**

The Contractor shall practice good housekeeping to maintain a safe job site. The contractor shall keep the work area, including any storage areas, free from the accumulation of waste materials. Upon completing work in an area the contractor shall remove any tools, equipment, and materials that are not the property of the government. Upon completion of work, the Contractor shall clean up the job site to the satisfaction of the Government.

**Government Resources:**

The contractor is responsible for providing all materials to complete the project. Unless specified in the contract, the Government will not provide any equipment, telephone services or other resources. Depending on availability, the contractor may use the restrooms, power, and water at the Surry Mountain and Otter Brook Lake Project Offices.

**Environmental Protection:**

Containers for excess and/or waste materials, rubbish, etc. shall be provided by the contractor at the site, and the site will be inspected/ cleaned on a daily basis. No burning is permissible. Water, air and land resources shall not be adversely impacted during the course of the work. Contractor will take necessary steps to ensure all federal, state, and local environmental regulatory requirements are met. Contractor must follow guidelines set forth in the Federal Acquisition Regulation Part 23.

**Omissions:**

This contract may not cover all specified activities, steps, and procedures required to supply the contract product. In case of omission, the normal industry, state, or federal standards, practices, specifications, and/or guides shall prevail. In no instance shall an omission be reason to produce less than an acceptable product.

**Quality Assurance:**

The contractor is responsible for the quality control of the contract work. The government has the right to inspect and test all items called for by the contract, to the extent practicable at all times and at all places during the term of the contract.

**Damage to Government or Private Property:**

The Contractor shall be responsible for restoring any Government facilities or structures damaged as a result of the firm's operation. The Contractor shall also be responsible for any damage to private property or injury to any person as a result of the firm's operations. The



Contractor shall notify the Technical Point of Contact immediately of damage to Government and private property and injury to any person resulting from the firms' operation.

**Other Contracts:**

The Government may undertake or award other contracts for additional work not related to this contract, and the Contractor shall fully cooperate with other Contractors and Government employees. The contractor shall not commit or permit any act, which will interfere with the performance of work by another contractor, or by Government employees.

**Receiving and Storing Materials:**

The contractor is responsible for protecting and storing material until it is placed in service. The contractor is responsible for receiving and unloading of delivered goods. Government employees will not receive material or supplies for the contractor and will not be responsible for damage to contractor equipment or material.

  - d. Non asphalt or bituminous based

- 5. Crushed Stone
  - a. 3/4 (three quarter) inch compactable

  - a. Rubber-asphalt type

- 8. Anchor Epoxy
  - a. High Strength
  - b. Two part
  - c. Suitable for use under static and seismic loading conditions in cracked and un-cracked concrete and masonry.

### **Part 3 Execution:**

1. **Both Otter Brook and Surry Mountain Lake locations shall follow the same execution procedures.**
2. **Demolition:**

The Contractor shall take all appropriate measures necessary to protect the surrounding areas, buildings, and pavement from damage during the execution of the work. If heavy equipment is to be used, ground mats must be placed prior to execution of work.

  - a. The contractor shall saw cut joint between concrete and asphalt for clean separation.
  - b. The contractor shall carefully remove and legally dispose of existing concrete aprons.
  - c. The contractor shall remove and legally dispose of concrete imbedded angle iron.
  - d. Clean up and square edges of garage floor sill.
  - e. Upon completion of the removal of all existing material, the excavated area must be inspected by the Technical Point of Contact.
  - f. The contractor shall not stock pile any material, or place waste containers directly on paved or lawn areas. If materials or containers need to be place on paved or lawn areas, a rigid barrier shall be placed in order to protect surfaces.
3. **Installation:**

- a. Excavate to proper depth and grade in order to allow for 4 (four) inches of compacted crushed stone with a 12 (twelve) inch by 12 (twelve) inch haunch at the toe of the slab plus 6 (six) inches of final grade concrete.
  - b. Grade and compact subgrade
  - c. Add crushed stone and compact to 95 (ninety-five) percent Proctor compaction for base. Base shall measure 4 (four) inches after compaction.
  - d. Excavated areas shall be formed and prepped with reinforcement bar, and mesh located with proper spacing and overlap to a 6 (six) inch depth, with a 12 (twelve) inch by 12 (twelve) inch haunch at the apron toe, per ACI (American Concrete Institute) standards for slabs.
  - e. Expansion joint material shall be placed in appropriate locations
  - f. 5/8 (five eighths) inch diameter holes shall be drilled to a minimum depth of 8 (eight) inches deep every 24 (twenty four) inches, centered along face of existing floor slabs to accept pins.
  - g. 36 (thirty six) inch, number 5 (five) rebar shall be epoxied into holes in order for 28 (twenty eight) inches of reinforcement bar to overhang into the formed apron space, centered to the depth of the slab. Proper drying time shall be followed prior to concrete pouring.
  - h. Pour concrete to existing grade and angle so that the finished product is a smooth transition from the apron to the garage floor and in such a way that it allows for complete closure and seal of overhead doors.
  - i. Finish concrete so that all edges are square to the building and straight
  - j. Final edge of garage door sill shall be completely level and square as to allow complete closure and seal of overhead doors.
  - k. Concrete shall be broom finished.
  - l. Leftover concrete shall be removed from the project.
  - m. Within 24 (twenty four) hours control joints shall be sawed along a line from the leading edge of the apron to the back, centered between overhead door openings.
  - n. Concrete shall be moist cured for a minimum of 7 days.
  - o. Concrete shall be sealed after 28 day drying period.
  - p. Joints between concrete and asphalt shall be sealed.
  - q. 5 year warranty on workmanship and materials.
4. **Clean Up:**
- a. The contractor shall remove and lawfully dispose off-site all of the waste materials generated during the execution of the work.
  - b. Site shall be left in equal to or better condition prior to start of construction.

## Section E - Inspection and Acceptance

## CLAUSES INCORPORATED BY FULL TEXT

## 52.246-12 INSPECTION OF CONSTRUCTION (AUG 1996)

(a) Definition. "Work" includes, but is not limited to, materials, workmanship, and manufacture and fabrication of components.

(b) The Contractor shall maintain an adequate inspection system and perform such inspections as will ensure that the work performed under the contract conforms to contract requirements. The Contractor shall maintain complete inspection records and make them available to the Government. All work shall be conducted under the general direction of the Contracting Officer and is subject to Government inspection and test at all places and at all reasonable times before acceptance to ensure strict compliance with the terms of the contract.

(c) Government inspections and tests are for the sole benefit of the Government and do not--

(1) Relieve the Contractor of responsibility for providing adequate quality control measures;

(2) Relieve the Contractor of responsibility for damage to or loss of the material before acceptance;

(3) Constitute or imply acceptance; or

(4) Affect the continuing rights of the Government after acceptance of the completed work under paragraph (i) of this section.

(d) The presence or absence of a Government inspector does not relieve the Contractor from any contract requirement, nor is the inspector authorized to change any term or condition of the specification without the Contracting Officer's written authorization.

(e) The Contractor shall promptly furnish, at no increase in contract price, all facilities, labor, and material reasonably needed for performing such safe and convenient inspections and tests as may be required by the Contracting Officer. The Government may charge to the Contractor any additional cost of inspection or test when work is not ready at the time specified by the Contractor for inspection or test, or when prior rejection makes reinspection or retest necessary. The Government shall perform all inspections and tests in a manner that will not unnecessarily delay the work. Special, full size, and performance tests shall be performed as described in the contract.

(f) The Contractor shall, without charge, replace or correct work found by the Government not to conform to contract requirements, unless in the public interest the Government consents to accept the work with an appropriate adjustment in contract price. The Contractor shall promptly segregate and remove rejected material from the premises.

(g) If the Contractor does not promptly replace or correct rejected work, the Government may (1) by contract or otherwise, replace or correct the work and charge the cost to the Contractor or (2) terminate for default the Contractor's right to proceed.

(h) If, before acceptance of the entire work, the Government decides to examine already completed work by removing it or tearing it out, the Contractor, on request, shall promptly furnish all necessary facilities, labor, and material. If the work is found to be defective or nonconforming in any material respect due to the fault of the Contractor or its subcontractors, the Contractor shall defray the expenses of the examination and of satisfactory reconstruction. However, if the work is found to meet contract requirements, the Contracting Officer shall make an equitable adjustment for the additional services involved in the examination and reconstruction, including, if

completion of the work was thereby delayed, an extension of time.

(i) Unless otherwise specified in the contract, the Government shall accept, as promptly as practicable after completion and inspection, all work required by the contract or that portion of the work the Contracting Officer determines can be accepted separately. Acceptance shall be final and conclusive except for latent defects, fraud, gross mistakes amounting to fraud, or the Government's rights under any warranty or guarantee.

## Section H - Special Contract Requirements

### SECURITY INFORMATION

The contractor and all associated sub-contractors shall receive a brief/training (provided by the RA) on the local suspicious activity reporting program. This locally developed training will be used to inform employees of the types of behavior to watch for and instruct employees to report suspicious activity to the project manager, security representative or law enforcement entity. This training shall be completed within 30 calendar days of contract award and within 30 calendar days of new employees commencing performance with the results reported to the Technical Point of Contact not later than 5 calendar days after the completion of the training.

52.223-2 AFFIRMATIVE PROCUREMENT OF BIOBASED PRODUCTS UNDER SERVICE AND CONSTRUCTION CONTRACTS (SEP 2013)

(a) In the performance of this contract, the contractor shall make maximum use of biobased products that are United States Department of Agriculture (USDA)-designated items unless--

(1) The product cannot be acquired--

(i) Competitively within a time frame providing for compliance with the contract performance schedule;

(ii) Meeting contract performance requirements; or

(iii) At a reasonable price.

(2) The product is to be used in an application covered by a USDA categorical exemption (see 7 CFR 3201.3(e)). For example, all USDA-designated items are exempt from the preferred procurement requirement for the following:

(ii) Military equipment, i.e., a product or system designed or procured for combat or combat-related missions.

(i) October 31 of each year during contract performance; and

(ii) At the end of contract performance.

52.225-9 BUY AMERICAN—CONSTRUCTION MATERIALS (MAY 2014)

(a) Definitions. As used in this clause--

Commercially available off-the-shelf (COTS) item—

(1) Means any item of supply (including construction material) that is--

- (i) A commercial item (as defined in paragraph (1) of the definition at FAR 2.101);
  - (ii) Sold in substantial quantities in the commercial marketplace; and
  - (iii) Offered to the Government, under a contract or subcontract at any tier, without modification, in the same form in which it is sold in the commercial marketplace; and
- (2) Does not include bulk cargo, as defined in 46 U.S.C. 40102(4) such as agricultural products and petroleum products.

Component means an article, material, or supply incorporated directly into a construction material.

Construction material means an article, material, or supply brought to the construction site by the Contractor or a subcontractor for incorporation into the building or work. The term also includes an item brought to the site preassembled from articles, materials, or supplies. However, emergency life safety systems, such as emergency lighting, fire alarm, and audio evacuation systems, that are discrete systems incorporated into a public building or work and that are produced as complete systems, are evaluated as a single and distinct construction material regardless of when or how the individual parts or components of those systems are delivered to the construction site. Materials purchased directly by the Government are supplies, not construction material.

Cost of components means--

- (1) For components purchased by the Contractor, the acquisition cost, including transportation costs to the place of incorporation into the construction material (whether or not such costs are paid to a domestic firm), and any applicable duty (whether or not a duty-free entry certificate is issued); or
- (2) For components manufactured by the Contractor, all costs associated with the manufacture of the component, including transportation costs as described in paragraph (1) of this definition, plus allocable overhead costs, but excluding profit. Cost of components does not include any costs associated with the manufacture of the construction material.

Domestic construction material means--

- (1) An unmanufactured construction material mined or produced in the United States;
- (2) A construction material manufactured in the United States, if--
  - (i) The cost of its components mined, produced, or manufactured in the United States exceeds 50 percent of the cost of all its components. Components of foreign origin of the same class or kind for which nonavailability determinations have been made are treated as domestic; or
  - (ii) The construction material is a COTS item.

Foreign construction material means a construction material other than a domestic construction material.

United States means the 50 States, the District of Columbia, and outlying areas.

(b) Domestic preference.

- (1) This clause implements 41 U.S.C. chapter 83, Buy American, by providing a preference for domestic construction material. In accordance with 41 U.S.C. 1907, the component test of the Buy American statute is waived for construction material that is a COTS item. (See FAR 12.505(a)(2)). The Contractor shall use only domestic construction material in performing this contract, except as provided in paragraphs (b)(2) and (b)(3) of this clause.

(2) This requirement does not apply to information technology that is a commercial item or to the construction materials or components listed by the Government as follows:

(3) The Contracting Officer may add other foreign construction material to the list in paragraph (b)(2) of this clause if the Government determines that

(i) The cost of domestic construction material would be unreasonable. The cost of a particular domestic construction material subject to the requirements of the Buy American Act is unreasonable when the cost of such material exceeds the cost of foreign material by more than 6 percent;

(ii) The application of the restriction of the Buy American Act to a particular construction material would be impracticable or inconsistent with the public interest; or

(iii) The construction material is not mined, produced, or manufactured in the United States in sufficient and reasonably available commercial quantities of a satisfactory quality.

(c) Request for determination of inapplicability of the Buy American Act. (1)(i) Any Contractor request to use foreign construction material in accordance with paragraph (b)(3) of this clause shall include adequate information for Government evaluation of the request, including--

(A) A description of the foreign and domestic construction materials;

(B) Unit of measure;

(C) Quantity;

(D) Price;

(E) Time of delivery or availability;

(F) Location of the construction project;

(G) Name and address of the proposed supplier; and

(H) A detailed justification of the reason for use of foreign construction materials cited in accordance with paragraph (b)(3) of this clause.

(ii) A request based on unreasonable cost shall include a reasonable survey of the market and a completed price comparison table in the format in paragraph (d) of this clause.

(iii) The price of construction material shall include all delivery costs to the construction site and any applicable duty (whether or not a duty-free certificate may be issued).

(iv) Any Contractor request for a determination submitted after contract award shall explain why the Contractor could not reasonably foresee the need for such determination and could not have requested the determination before contract award. If the Contractor does not submit a satisfactory explanation, the Contracting Officer need not make a determination.

(2) If the Government determines after contract award that an exception to the Buy American statute applies and the Contracting Officer and the Contractor negotiate adequate consideration, the Contracting Officer will modify the contract to allow use of the foreign construction material. However, when the basis for the exception is the



unreasonable price of a domestic construction material, adequate consideration is not less than the differential established in paragraph (b)(3)(i) of this clause.

(3) Unless the Government determines that an exception to the Buy American statute applies, use of foreign construction material is noncompliant with the Buy American statute.

(d) Data. To permit evaluation of requests under paragraph (c) of this clause based on unreasonable cost, the Contractor shall include the following information and any applicable supporting data based on the survey of suppliers:

The contractor shall have each applicable employee complete a SF-85P and submit to the U.S. Army Engineer District, New England, 696 Virginia Road, Concord, MA 01742-2751, Security Officer, within three (3) working days after award of any contract or task order, and shall be submitted prior to the individual being permitted to access AIS. Contractors that have a commercial or government entity (CAGE) Code and Facility Security Clearance through the Defense Security Service shall process the NAC’s and forward visit requests/results of NAC to the U.S. Army Engineer District, New England, 696 Virginia Road, Concord, MA 01742-2751 – Security Officer. For those contractors that do not have a Cage Code or Facility Security Clearance, the U.S. Army Engineer District, New England – Bldg 1, 696 Virginia Road, Concord, MA 01742-2751, Security Officer will process the investigation in coordination with the Contractor and contract employees.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

#### Survey Rate Identifiers

Classifications listed under the "SU" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.
