## Compliance

### Commission Seeks Comment on Enforcement Process

The Commission is seeking public comment on certain aspects of its enforcement process and, more generally, whether the agency is effectively enforcing the Federal Election Campaign Act and Commission regulations. The comments received will be considered in determining whether the agency's enforcement policies and procedures should be altered and whether rulemaking is advised. The Request for Comment was published in the *Federal Register* on January 18, 2013.

The Commission is particularly interested in hearing from complainants and respondents who interact directly with the agency, including committee treasurers and other persons who may become involved in the enforcement process. Specific topics include:

- The Office of General Counsel's use of media reports and other publicly available information in forming recommendations to the Commission as to whether there is "reason to believe" a violation may have occurred;
- The formulas the agency uses to calculate civil penalties; and
- The Commission's practice of seeking disgorgement of funds in addition to penalties for certain violations.

The notice also poses questions about the Commission's Alternative Dispute Resolution (ADR) program and whether the agency's policy of accepting or rejecting proposed ADR settlements is effective. ## **Message from the Reports Analysis Division (RAD) – Process Change Notification**

The Reports Analysis Division (RAD) will begin sending Non-Filer Notifications via email in February 2013. Non-Filer Notifications are sent when a required Report of Receipts and Disbursements (Forms 3, 3X, 3P), or a Report of Contributions Bundled by Lobbyists/Registrants and Lobbyist/Registrant PACs (Form 3L) has not been received at the FEC. Please note that you will no longer receive paper Non-Filer Notifications through the mail once this process begins.

To provide an e-mail address or update your current email address, please file an amended Statement of Organization (FEC Form 1).

If you would prefer to continue to receive Non-Filer Notifications on paper, please file a miscellaneous document ([Form 99 for electronic filers](#)) to indicate this preference.

## **Supreme Court Allows Disclosure Ruling to Stand in *RTAA v. FEC***

The United States Supreme Court has let stand an appeals court ruling that upheld Federal Election Commission legal definitions and policies regarding the disclosure of certain information by the nonprofit The Real Truth About Abortion (RTAA) – formerly known as The Real Truth About Obama, Inc.

RTAA had argued that the Commission's definition of "express advocacy" and approach to determining whether a group is a "political committee" under the Federal Election Campaign Act (Act) were vague, overbroad, and violated the First and Fifth Amendments to the Constitution. A three-judge panel of the United States Court of Appeals for the Fourth Circuit rejected that challenge, finding the Commission's definition of express advocacy consistent with relevant Supreme Court decisions, and the Commission's political committee determinations to be "a sensible approach" that "does not unlawfully deter protected speech."

On January 7, 2012, the Supreme Court denied RTAA's petition for *writ of certiorari*, letting stand the appeals court's decision.

## Commission Certifies Federal Matching Funds for Gary Johnson

The Federal Election Commission has certified \$121,755.77 in federal matching funds to Governor Gary Johnson/Gary Johnson 2012, Inc. for the 2012 primary election. The United States Treasury Department transferred the certified amount on January 8, 2013.

This raises the total amount of federal funds certified to Governor Gary Johnson/Gary Johnson 2012, Inc., to \$632,016.75. Governor Gary Johnson/Gary Johnson 2012, Inc. is the authorized committee of Gary Earl Johnson, the Libertarian Party's presidential candidate.

Last year, the Commission also certified \$351,961.10 in federal matching funds to Charles E. "Buddy" Roemer III and \$372,130.44 to Jill Stein for President for the primary.

To become eligible for matching funds, a candidate must raise a threshold amount of \$100,000 by collecting \$5,000 in each of 20 states in amounts no greater than \$250 from any individual. Other requirements include agreeing to an overall spending limit, abiding by spending limits in each state, using public funds only for qualified campaign-related expenses, keeping financial records and permitting an extensive campaign audit.

The presidential public funding program is financed through the \$3 check-off that appears on individual income tax returns. The program has three elements: matching payments to participating candidates during the primary campaign, grants to parties to help fund their nominating conventions, and grants available to nominees to pay for the general election.
