

Analyzing the results of the FY 2012 Employee Viewpoint Survey provides the Commission with an opportunity to continue to build on its strengths and to focus on the challenges it faces. The most positive responses and the area of strengths for the Commission remain in "My Work Experience", whereas the most negative results and significant challenges for the Commission are in the area of "My Agency". Responses remained positive in the area of supervision; however they declined in overall leadership.

FY 2012, in particular has been a challenging year for the employees of the Commission. Vacancies in key positions left the agency without permanent employees in the positions of Staff Director (who is the administrative head of the agency), General Counsel and Head of its Office of Civil Rights Evaluation. The agency is confident that the filling of these key positions as well as others will allow it to take a serious look at the Employee Viewpoint Survey and to develop an action plan to address all areas.

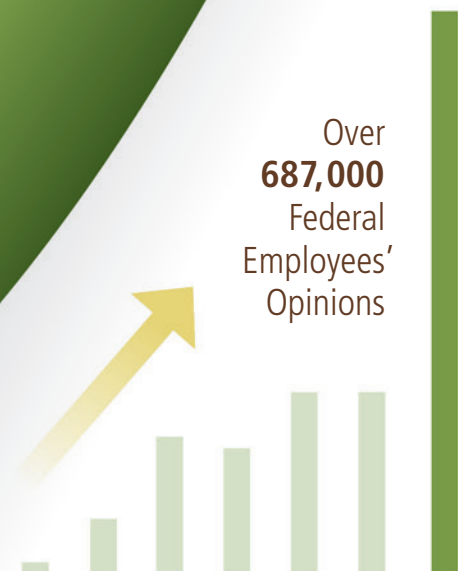
