Ohio State Advisory Committee to Hold Forum in Toledo Examining Human Trafficking in Ohio

CHICAGO, IL – The Ohio State Advisory Committee to the U. S. Commission on Civil Rights will conduct a community forum on June 5 and 6 investigating the causes and responses to Ohio's being named, in some reports, as one of the five worst states in the nation for human trafficking. The forum will follow up and monitor changes made since Attorney General Mike DeWine reconvened the Ohio Attorney General's Human Trafficking Commission, which launched initiatives to address the problem.

The meeting will be held at THE HOTEL @ UTMC, 3100 Glendale Ave., Toledo, OH 43614 from 1:00 p.m. ET to 6:00 p.m.ET on Wednesday, June 5, and 9:00 a.m. ET to 1:00 p.m. ET on Thursday, June 6. An agenda is below.

An open session where the public will be given an opportunity to provide testimony on the record will be held at the end of each day.
