IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2015

IMPORTS

U.S. imports of edible fishery products in 2015 were valued at \$18.8 billion, down 7.1 percent from 2014. The quantity of edible imports was 2,604,140 metric tons, an increase of 79,748 tons (up 3.2 percent) from the quantity imported in 2014.

The volume of shrimp imported in 2015 was 585,826 tons, an increase of 18,153 tons, or 3.2 percent, from the quantity imported in 2014. Shrimp Imports were valued at \$5.4 billion, a decrease of \$1.2 billion (18.6 percent) from 2014. Shrimp imports accounted for 29.0 percent of the value of total edible imports. Imports of fresh and frozen salmon were 329,845 tons valued at \$2.5 billion in 2015. Imports of fresh and frozen tuna were 183,631 tons, up 17,336 tons (10.4 percent) from 2014. The value of fresh and frozen tuna imports increased by 5.6 percent to \$1.0 billion. Imports of canned tuna were 142,145 tons, down 13,032 tons (8.4 percent) from 2014. The value of canned tuna imports also decreased, dropping \$90.2 million (13.5 percent) from 2014. Imports of all fresh and frozen fillets and steaks amounted to 722,778 tons, an increase of 7,569 tons (1.1 percent) from 2014. Total edible imports consisted of: 2,199,593 tons of fresh and frozen products valued at \$16.4 billion; 316,556 tons of canned products valued at \$1.8 billion; 45,223 tons of cured products valued at \$316.2 million; 2,989 tons of caviar and roe products valued at \$44.4 million; and 39,768 tons of other products valued at \$223.7 million.

Imports of nonedible fishery products were valued at \$15.5 billion, \$137,499 million (< 1 percent) less than in 2014. Total value of edible and nonedible fishery imports was \$34.3 billion in 2015, \$1.6 billion (4.4 percent) less than in 2014.

EXPORTS

U.S. exports of edible fishery products of domestic origin in 2015 were 1,378,364 tons valued at \$5.2 billion, a decrease of 113,114 tons (7.6 percent) and \$134.9 million (2.5 percent) over 2014.

Exports of fresh and frozen items were 1,259,450 tons valued at \$4.4 billion, a decrease of 114,482 tons (8.3 percent) and a decrease in value of \$122.0 million (2.7 percent) compared with 2014. Fresh and frozen exports consisted principally of 206,016 tons of salmon valued at \$704.9 million; 49,198 tons of lobster (*Homarus spp.*) valued at \$628.3 million; and 182,526 tons of surimi valued at \$431.4 million. Exported canned items totaled 60,833 tons valued at \$307.0 million. Salmon was the major canned item exported, with 39,211 tons valued at \$196.6 million. Cured items accounted for 4,876 tons of exports valued at \$18.8 million. Caviar and roe exports were 45,494 tons valued at \$392.3 million. Other edible products accounted for 7,710 tons valued at \$45.3 million.

Exports of nonedible products were valued at \$16.8 billion. Exports of fish meal amounted to 147,466 tons valued at \$180.6 million. The total value of edible and nonedible exports was \$22.0 billion, \$1.2 billion (5.2 percent) less than in 2014.

RE-EXPORTS

U.S. exports of edible fishery products of foreign origin in 2015 were 46,487 tons valued at \$358.3 million, a decrease of 5,190 tons (10.0 percent) and a decrease of \$52.6 million (12.8 percent) from 2014.

Fresh and frozen items were 42,221 tons valued at \$319.7 million. This reflects a decrease of 4,625 tons and a decrease of \$51.8 million compared with 2014. Shrimp (3,122 tons valued at \$32.6 million), salmon (9,801 tons valued at \$77.0 million), crabs (965 tons valued at \$16.2 million) and tuna (1,539 tons valued at \$8.0 million) were the principle fresh and frozen products re-exported. Canned items accounted for 1,564 tons valued at 6.4 million. Cured products were 494 tons valued at \$4.6 million. Caviar and roe re-exports were 585 tons valued at \$15.3 million. Other edible products were 1,000 tons valued at \$9.1 million.

Re-exports of nonedible fishery products were valued at \$6.0 billion. Fish oils accounted for 2,046 tons valued at \$18.5 million. The total value of edible and nonedible re-exports was \$6.4 billion, \$375.5 million less than in 2014.

NOTES:

Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of “domestic” merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of “foreign” products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacturing. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the “Customs value.” It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.

(1) Includes landings of foreign caught tuna in American Samoa. Such landings are not included in census data since American Samoa is outside the U.S. Customs territory. The value of these landings is estimated.

(3) Not reported in kilos. Quantity is reported in: number of individual pieces, square meters, and in some cases, quantity is not required to be reported.
