## Deputy Assistant Secretary of the Navy (Reserve Affairs/Total Force Integration) Office of the Assistant Secretary of the Navy (Manpower & Reserve Affairs)



Mr. Dennis Biddick assumed the position of Deputy Assistant Secretary of the Navy for Reserve Affairs on January 18, 2010. More recently the position has been updated to include responsibilities for Total Force Integration. In this position Mr. Biddick acts as the principal advisor to the ASN (M&RA) on policy and program matters relating to Navy and Marine Corps Reserve personnel and programs. Additionally, he provides senior level oversight and guidance on manpower and personnel issues that impact the balance of the Total Force – military, civilians and contractors. His previous SES assignment was as the Deputy Assistant Secretary of Navy (Infrastructure Strategy & Analysis) charged with providing leadership and guidance for overall basing and infrastructure requirements and the competitive sourcing program for the Department.

Mr. Biddick has been a member of the Senior Executive Service since January 2007 and has seven years of Federal civilian service.

Prior to his SES assignments, Mr. Biddick spent just over a year with Fluor Corporation as an operations/program manager for their government group. Fluor is one of the largest engineering, procurement, construction and maintenance contractors in the country. From December 2003 to December 2005, he was the Chief of Staff for the Infrastructure Analysis Team for Base Realignment and Closure (BRAC) 2005.

In September 2003, Mr. Biddick completed a 27 plus-year Navy career as he retired as a Captain in the Civil Engineer Corps. His last assignment on active duty was as the Commanding Officer of the Navy Public Works Center, Washington D.C. as well as the Regional Engineer for Naval District Washington.

Mr. Biddick's other assignments during his military career included: tours in Washington DC at Headquarters, Naval Facilities Engineering Command and four years working BRAC in the mid-1990's as an analyst and implementer; Executive Officer for the Naval Construction Battalion Center, Port Hueneme, Calif. heading the efforts to regionalize that installation with Naval Air Station, Pt Mugu to eventually form Naval Base Ventura County; Resident Officer in Charge of Construction for the Navy's newest homeport, Naval Station, Everett, Wash; Acquisition Head for Navy Public Works Center, San Diego, Calif.; Contracts Instructor, Civil Engineer Corps

Officer School, Port Hueneme, Calif.; and various other public works, acquisition and Seabee tours of duty.

Mr. Biddick holds a bachelor's degree in civil engineering from Villanova University and a master's in civil engineering from Penn State University. He is a certified Acquisition Professional and is a registered Professional Engineer in the State of California.
