Mr. Quentmeyer is the Deputy Director, Office of Financial Operations, Office of the Assistant Secretary of the Navy (Financial Management and Comptroller). He provides executive oversight and direction for the Department of the Navy (DON) finance and accounting operations and reporting, to include development and implementation for policies, processes, and systems. Additionally, he is responsible for general oversight of the DON's Financial Improvement Program, the Navy Manager's Internal Control Program, and serves as the Chief Accounting Officer.

Mr. Quentmeyer entered the Senior Executive Service (SES) with the Department of the Navy in November, 2012. Prior to this appointment, he served in the SES as a Senior Intelligence Officer with the United States Intelligence Community since February, 2005.

Consulting Practice, Finance and Cost Management, and Information Technology lines of business delivering client services.

Mr. Quentmeyer received a regular commission as a Second Lieutenant in the United States Marine Corps (USMC) in 1975, and retired as a Lieutenant Colonel in 1997. He served as a Financial Management Officer and Infantry Officer in various assignments and locations, to include Stuttgart, Germany; and Okinawa, Japan. His service included a

joint tour as an International Politico-Military Affairs Officer, Europe Division, J-5 Plans and Policy Directorate, Headquarters, United States European Command; and as the Assistant Chief of Staff, J-5 Plans, Headquarters, Joint Task Force Provide Promise.

Mr. Quentmeyer holds a bachelor's of science degree in accounting and business administration from Union College, a master's of arts degree in human resources management from Pepperdine University, a master's of business administration from Webster University, and is a Certified Government Financial Manager (CGFM).
