

Imports and Exports of Fishery Products Annual Summary, 1998

IMPORTS. U.S. imports of edible fishery products in 1998 were valued at \$8.2 billion, \$418.9 million higher than in 1997. The quantity of edible imports was 1,654,279 metric tons, a 139,787 ton increase from the quantity imported in 1997.

The quantity of shrimp imported in 1998 was 315,442 tons, 21,365 tons more than the quantity imported in 1997. Valued at \$3.1 billion, shrimp imports accounted for 38 percent of the value of total edible imports. Imports of fresh and frozen tuna were 259,004 tons, 60,105 tons more than imported in 1997. Imports of canned tuna were 109,049 tons, 12,809 tons more than in 1997. Imports of fresh and frozen fillets and steaks amounted to 262,434 tons, an increase of 28,920 tons from 1997. Regular and minced block imports were 105,617 tons, a decrease of 512 tons from 1997. Edible imports consisted: of 1,414,856 tons of fresh and frozen products valued at \$7.4 billion; 194,220 tons of canned products valued at \$587.6 million; 32,757 tons of cured products valued at \$140.6 million; 1,977 tons of caviar and roe products valued at \$33.2 million; and 10,469 tons of other products valued at \$55.9 million.

Imports of nonedible fishery products were valued at \$7.5 billion, \$685.4 million higher than imported in 1997. Total value of edible and nonedible products resulted in a record import value of \$15.6 billion in 1998, \$1.1 billion higher than in 1997, when \$14.5 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 744,449 tons valued at \$2.2 billion, compared with 894,499 tons at \$2.6 billion exported in 1997.

Fresh and frozen items were 631,627 tons valued at \$1.7 billion, a decrease of 151,140 tons and \$342.0 million compared with 1997. Fresh and frozen exports consisted principally of 67,469 tons of salmon valued at \$247.5 million, 115,376 tons of surimi valued at \$247.5 million, and 22,798 tons of crabs valued at \$107.9 million. Canned items were 64,622 tons valued at \$206.7 million. Salmon was the major canned item exported, with 34,934 tons valued at \$142.6 million. Cured items were 6,909 tons valued at \$22.6 million. Caviar and roe exports were 32,723 tons valued at \$256.5 million. Other edible products accounted for 8,568 tons valued at \$16.1 million.

Exports of nonedible products were valued at \$5.5 billion. Exports of fish meal amounted to 95,160 tons valued at \$67.4 million. The total value of edible and nonedible exports was \$7.7 billion, \$662.1 million less than in 1997.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 21,667 tons valued at \$102.4 million, compared to 21,263 tons valued at \$110.4 million re-exported in 1997. Fresh and frozen items were 20,438 tons valued at \$95.0 million an increase of 730 tons but a decrease of \$4.0 million compared with 1997. Fresh and frozen shrimp was the principle product at 3,977 tons valued at \$36.5 million. Canned items accounted for 805 tons valued at \$4.5 million. Cured products were 116 tons valued at \$583 thousand. Caviar and roe re-exports were 110 tons valued at \$1.5 million. Other edible products were 198 tons valued at \$779 thousand.

Re-exports of nonedible fishery products were valued at \$948.2 million. Fish oils accounted for 1,173 tons valued at \$896 thousand and fish meal amounting to 394 tons valued at \$1.0 million. The total value of edible and nonedible re-exports was \$1.0 billion, \$13.9 million higher than in 1997.

NOTES. Unless otherwise noted, the information presented is based on Bureau of the Census data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs Service, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
