IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2010

IMPORTS. U.S. imports of edible fishery products in 2010 were valued at \$14.8 billion, \$1.7 billion more than in 2009. The quantity of edible imports was 2,474,946 metric tons, an increase of 133,704 tons (5.7 percent) from the quantity imported in 2009.

The volume of shrimp imported in 2010 was 558,602 tons, an increase of 10,063 tons, or 1.8 percent, from the quantity imported in 2009. Valued at \$4.3 billion, shrimp imports accounted for 28.9 percent of the value of total edible imports. Imports of fresh and frozen salmon, including fillets, were 221,744 tons valued at \$1.7 billion in 2010. This quantity represents a 2.4 percent decrease over the figure for 2009 while the value represents a 9.3 percent increase. Imports of fresh and frozen tuna were 215,694 tons, 51,440 tons more than imported in 2009. Similarly, the value of fresh and frozen tuna imports increased by 31.0 percent to \$875 million. Imports of canned tuna were 200,653 tons, an increase of 20,130 tons from 2009, and the value of canned tuna imports increased 7.6 percent to \$660 million. Imports of all fresh and frozen fillets and steaks amounted to 601,620 tons, an increase of 34,188 tons from 2009. Regular and minced block imports were 63,997 tons, an increase of 548 tons from 2009. Total edible imports consisted of: 2,052,867 tons of fresh and frozen products valued at \$12.8 billion; 349,263 tons of canned products valued at \$1.6 billion; 41,568 tons of cured products valued at \$256 million; 2,493 tons of caviar and roe products valued at \$31 million; and 28,755 tons of other products valued at \$121 million.

Imports of nonedible fishery products were valued at \$12.6 billion, \$2.15 billion more than in 2009. Total value of edible and nonedible fishery imports was \$27.4 billion in 2010, \$3.8 billion more than in 2009.

EXPORTS. U.S. exports of edible fishery products of domestic origin in 2010 were 1,202,846 tons valued at \$4.13 billion, compared with 1,119,732 tons at \$3.74 billion exported in 2009.

Exports of fresh and frozen items were 1,077,310 tons valued at \$3.5 billion, an increase of 89,980 tons and an increase in value of \$454 million compared with 2009. Fresh and frozen exports consisted principally of 161,000 tons of salmon valued at \$587.1 million, 31,449 tons of lobster (*Homarus spp.*) valued at \$363.7 million, and 104,289 tons of surimi valued at \$287.3 million. Exported canned items totaled 73,992 tons valued at \$237.5 million. Salmon was the major canned item exported, with 41,038 tons valued at \$179.0 million. Cured items accounted for 1,673 tons of exports valued at \$10.5 million. Caviar and roe exports were 31,765 tons valued at \$321.9 million. Other edible products accounted for 18,106 tons valued at \$62.5 million.

Exports of nonedible products were valued at \$15.3 billion. Exports of fish meal amounted to 76,512 tons valued at \$95.5 million. The total value of edible and nonedible exports was \$19.5 billion, \$2.4 billion more than in 2009.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 36,241 tons valued at \$245.8 million, compared to 35,245 tons valued at \$241.9 million re-exported in 2009. Fresh and frozen items were 32,479 tons valued at \$214.6 million. This reflects decreases of 24 tons and \$8.3 million compared with 2009. Shrimp (2,215 tons valued at \$20.7 million), salmon (792 tons valued at \$4.5 million), crabs (885 tons valued at \$13.0 million) and tuna (1,982 tons valued at \$11.1 million) were the principle fresh and frozen products re-exported. Canned items accounted for 1,648 tons valued at \$10.7 million. Cured products were 309 tons valued at \$3.9 million. Caviar and roe re-exports were 645 tons valued at \$10.3 million. Other edible products were 1,160 tons valued at \$6.2 million.

Re-exports of nonedible fishery products were valued at \$2.6 billion. Fish oils accounted for 2,390 tons valued at \$7.0 million. The total value of edible and nonedible re-exports was \$2.9 billion, \$308.8 million more than in 2009.

NOTES. Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
