

IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 1997

IMPORTS. U.S. imports of edible fishery products in 1997 were valued at \$7.8 billion, \$1.0 billion higher than in 1996. The quantity of edible imports was 1,514,492 metric tons, a 76,686 ton increase from the quantity imported in 1996.

The quantity of shrimp imported in 1997 was 294,077 tons, 29,870 tons more than the quantity imported in 1996. Valued at \$2.9 billion, shrimp imports accounted for 38 percent of the value of total edible imports. Imports of fresh and frozen tuna were 198,899 tons, 40,919 tons less than imported in 1996. Imports of canned tuna were 96,240 tons, 8,679 tons more than in 1996. Imports of fresh and frozen fillets and steaks amounted to 233,514 tons, an increase of 17,389 tons from 1996. Regular and minced block imports were 106,129 tons, a decrease of 108 tons from 1996. Edible imports consisted: of 1,297,985 tons of fresh and frozen products valued at \$7.0 billion; 175,583 tons of canned products valued at \$525.3 million; 31,314 tons of cured products valued at \$131.6 million; 1,944 tons of caviar and roe products valued at \$31.2 million; and 7,666 tons of other products valued at \$44.2 million.

Imports of nonedible fishery products were valued at \$6.8 billion, \$443.3 million higher than imported in 1996. Total value of edible and nonedible products resulted in a record import value of \$14.5 billion in 1997, \$1.5 billion higher than in 1996, when \$13.1 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 894,499 tons valued at \$2.6 billion, compared with 931,720 tons at \$2.9 billion exported in 1996.

Fresh and frozen items were 782,767 tons valued at \$2.0 billion, a decrease of 9,055 tons and \$168.3 million compared with 1996. Fresh and frozen exports consisted principally of 84,309 tons of salmon valued at \$300.0 million, 140,143 tons of surimi valued at \$329.5 million, and 19,418 tons of crabs valued at \$107.4 million. Canned items were 57,493 tons valued at \$193.4 million. Salmon was the major canned item exported, with 36,762 tons valued at \$134.4 million. Cured items were 4,659 tons valued at \$20.0 million. Caviar and roe exports were 40,771 tons valued at \$368.3 million. Other edible products accounted for 8,809 tons valued at \$15.2 million.

Exports of nonedible products were valued at \$5.7 billion. Exports of fish meal amounted to 97,981 tons valued at \$57.1 million. The total value of edible and nonedible exports was \$8.3 billion, \$607.3 million higher than in 1996.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 21,263 tons valued at \$110.4 million, compared to 26,302 tons valued at \$128.5 million re-exported in 1996. Fresh and frozen items were 19,708 tons valued at \$99.1 million a decrease of 4,385 tons and \$21.4 million compared with 1996. Fresh and frozen shrimp was the principle product at 4,268 tons valued at \$41.0 million. Canned items accounted for 1,244 tons valued at \$9.3 million. Cured products were 145 tons valued at \$890 thousand. Caviar and roe re-exports were 34 tons valued at \$795 thousand. Other edible products were 132 tons valued at \$375 thousand.

Re-exports of nonedible fishery products were valued at \$926.3 million. Fish oils accounted for 735 tons valued at \$833 thousand and fish meal amounting to 127 tons valued at \$128 thousand. The total value of edible and nonedible re-exports was \$1.0 billion, \$92.8 million higher than in 1996.

NOTES. Unless otherwise noted, the information presented is based on Bureau of the Census data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs Service, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
