# IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2009

**IMPORTS.** U.S. imports of edible fishery products in 2009 were valued at \$13.1 billion, \$1 billion less than in 2008. The quantity of edible imports was 2,341,242 metric tons, a decrease of 29,234 tons (1.2 percent) from the quantity imported in 2008.

The volume of shrimp imported in 2009 was 548,539 tons, a decrease of 15,701 tons, or 2.8 percent, from the quantity imported in 2008. Valued at \$3.8 billion, shrimp imports accounted for 28.6 percent of the value of total edible imports. Imports of fresh and frozen salmon, including fillets, were 227,182 tons valued at \$1.6 billion in 2009. This quantity represents a 0.7 percent decrease over the figure for 2008 while the value represents a 1.1 percent increase. Imports of fresh and frozen tuna were 164,254 tons, 20,483 tons less than imported in 2008. Similarly, the value of fresh and frozen tuna imports decreased by 9.7 percent to \$668 million. Imports of canned tuna were 180,523 tons, an increase of 9,165 tons from 2008, but the value of canned tuna imports decreased 7.3 percent to \$613 million. Imports of all fresh and frozen fillets and steaks amounted to 567,432 tons, an increase of 11,663 tons from 2008. Regular and minced block imports were 63,449 tons, a decrease of 1,000 tons from 2008. Total edible imports consisted of: 1,948,947 tons of fresh and frozen products valued at \$11.3 billion; 324,991 tons of canned products valued at \$1.4 billion; 41,091 tons of cured products valued at \$256.0 million; 2,899 tons of caviar and roe products valued at \$28 million; and 23,314 tons of other products valued at \$110 million.

Imports of nonedible fishery products were valued at \$8.7 billion, \$5.6 billion less than in 2008. Total value of edible and nonedible fishery imports was \$21.8 billion in 2009, \$6.6 billion less than in 2008.

**EXPORTS.** U.S. exports of edible fishery products of domestic origin in 2009 were 1,119,732 tons valued at \$3.74 billion, compared with 1,161,843 tons at \$3.99 billion exported in 2008.

Exports of fresh and frozen items were 987,330 tons valued at \$3.0 billion, a decrease of 17,761 tons and a decrease in value of \$123 million compared with 2008. Fresh and frozen exports consisted principally of 131,418 tons of salmon valued at \$440.3 million, 23,103 tons of lobster (*Homarus spp.*) valued at \$305.2 million, and 86,671 tons of surimi valued at \$212.3 million. Exported canned items totaled 74,157 tons valued at \$268.8 million. Salmon was the major canned item exported, with 43,901 tons valued at \$192.9 million. Cured items accounted for 1,870 tons of exports valued at \$10.8 million. Caviar and roe exports were 34,269 tons valued at \$335.4 million. Other edible products accounted for 22,106 tons valued at \$75.2 million.

Exports of nonedible products were valued at \$13.3 billion. Exports of fish meal amounted to 72,919 tons valued at \$71.5 million. The total value of edible and nonedible exports was \$17.1 billion, \$3.7 billion less than in 2008.

**RE-EXPORTS.** U.S. exports of edible fishery products of foreign origin were 35,245 tons valued at \$241.9 million, compared to 40,234 tons valued at \$268.5 million re-exported in 2008. Fresh and frozen items were 32,503 tons valued at \$222.9 million. This reflects decreases of 5,020 tons and \$20.4 million compared with 2008. Shrimp (2,621 tons valued at \$24.7 million), salmon (1,040 tons valued at \$5.7 million), crabs (1,009 tons valued at \$13.8 million) and tuna (1,596 tons valued at \$8.6 million) were the principle fresh and frozen products re-exported. Canned items accounted for 1,553 tons valued at \$5.8 million. Cured products were 452 tons valued at \$4.8 million. Caviar and roe re-exports were 321 tons valued at \$6.0 million. Other edible products were 416 tons valued at \$2.3 million.

Re-exports of nonedible fishery products were valued at \$2.3 billion. Fish oils accounted for 1,850 tons valued at \$6.5 million. The total value of edible and nonedible re-exports was \$2.6 billion, \$41.4 million less than in 2008.

NOTES. Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
