

## **IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 1996**

IMPORTS. U.S. imports of edible fishery products in 1996 were valued at \$6.7 billion, \$62.1 million lower than in 1995. The quantity of edible imports was 1,437,806 metric tons, a 46,870 ton increase from the quantity imported in 1995.

The quantity of shrimp imported in 1996 was 264,207 tons, 6,683 tons less than the quantity imported in 1995. Valued at \$2.5 billion, shrimp imports accounted for 36 percent of the value of total edible imports. Imports of fresh and frozen tuna were 239,818 tons, 14,890 tons more than imported in 1995. Imports of canned tuna were 87,561 tons, 10,128 tons less than in 1995. Imports of fresh and frozen fillets and steaks amounted to 216,125 tons, a decrease of 460 tons from 1995. Regular and minced block imports were 106,237 tons, an increase of 10,857 tons from 1995. Edible imports consisted: of 1,236,876 tons of fresh and frozen products valued at \$6.0 billion; 160,777 tons of canned products valued at \$473.7 million; 30,580 tons of cured products valued at \$131.7 million; 2,308 tons of caviar and roe products valued at \$35.3 million; and 7,265 tons of other products valued at \$45.1 million.

Imports of nonedible fishery products were valued at \$6.3 billion, \$670.8 million higher than imported in 1995. Total value of edible and nonedible products resulted in a record import value of \$13.1 billion in 1996, \$608.7 million higher than in 1995, when \$12.5 billion of fishery products were imported.

EXPORTS. U.S. exports of edible fishery products of domestic origin were 931,720 tons valued at \$2.9 billion, compared with 906,376 tons at \$3.1 billion exported in 1995.

Fresh and frozen items were 791,822 tons valued at \$2.2 billion, an increase of 12,452 tons but a decrease of \$201.5 million compared with 1995. Fresh and frozen exports consisted principally of 124,266 tons of salmon valued at \$463.0 million, 128,470 tons of surimi valued at \$268.1 million, and 21,150 tons of crabs valued at \$162.0 million. Canned items were 68,941 tons valued at \$219.5 million. Salmon was the major canned item exported, with 42,924 tons valued at \$152.8 million. Cured items were 10,304 tons valued at \$40.6 million. Caviar and roe exports were 50,157 tons valued at \$449.4 million. Other edible products accounted for 10,496 tons valued at \$20.2 million.

Exports of nonedible products were valued at \$4.8 billion. Exports of fish meal amounted to 83,710 tons valued at \$52.3 million. The total value of edible and nonedible exports was \$7.7 billion, \$158.4 million higher than in 1995.

RE-EXPORTS. U.S. exports of edible fishery products of foreign origin were 26,302 tons valued at \$128.5 million, compared to 22,219 tons valued at \$120.9 million re-exported in 1995. Fresh and frozen items were 24,093 tons valued at \$120.5 million an increase of 3,474 tons and \$7.8 million compared with 1995. Fresh and frozen shrimp was the principle product at 5,608 tons valued at \$53.0 million. Canned items accounted for 1,551 tons valued at \$4.3 million. Cured products were 216 tons valued at \$1.2 million. Caviar and roe re-exports were 142 tons valued at \$1.5 million. Other edible products were 300 tons valued at \$1.0 million.

Re-exports of nonedible fishery products were valued at \$815.4 million. Fish oils accounted for 2,176 tons valued at \$1.4 and fish meal amounting to 846 tons valued at \$596 thousand. The total value of edible and nonedible re-exports was \$943.9 million, \$226.9 million higher than in 1995.

**NOTES.** Unless otherwise noted, the information presented is based on Bureau of the Census data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of "domestic" merchandise to include commodities which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of "foreign" products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacture. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the "Customs value." It is based on the value of the product in the country of origin as appraised by the U.S. Customs Service, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
