Dear Reader:

The Bureau of Land Management (BLM) received an Expression of Interest (nomination) to sell Federal oil and gas leases on 1 parcel of Federal minerals in a future lease sale. The parcel is located within the North Dakota Field Office (NDFO) area in Williams County. The preliminary parcel list with recommended stipulations is posted on our website, listed below, for a 15-day scoping period for your review.

The BLM makes mineral resources available for use to meet national, regional, and local needs. Under the Federal Onshore Oil and Gas Leasing Reform Act of 1987, the BLM conducts oil and gas lease sales quarterly in each state whenever eligible lands are available for leasing. Prior to offering nominated parcels for lease at a sale, if analysis is warranted, BLM will complete an environmental assessment (EA) to disclose the potential impacts from issuing Federal oil and gas leases and identify stipulations that would be included with each lease.

We have posted a preliminary parcel list with recommended stipulations on our website for your review. Please refer to the Montana/Dakotas BLM website at http://www.blm.gov/mt/st/en/prog/energy/oil_and_gas/leasing/leasesaleinfo.html. Current and updated information about our EAs, Lease Sale Notices, and corresponding information pertaining to this sale can be found at the link referenced above. Once there, search for the January 26, 2016 lease sale to review the preliminary parcel list with recommended stipulations.


