AMENDMENT 4 TO THE NORTHEAST FISHERY SECTOR III SECTOR OPERATIONS PLAN

APPROVED BY THE NATIONAL MARINE FISHERIES SERVICE AUGUST 16, 2011

EFFECTIVE AUGUST 16, 2011, THROUGH APRIL 30, 2012 - THE 2011 FISHING YEAR

This amendment approves 1 additional exemption for Northeast Fishery Sector III. The new exemption is from the:

1. Requirement to maintain a vessel monitoring system (VMS) powered while at the dock.

The following exemptions were previously approved for Northeast Fishery Sector III and remain in effect:

- 1. 120-Day Block Requirement Out of the Fishery for Day Gillnet Vessels
- 2. Prohibition on a Vessel Hauling Another Vessel's Gillnet Gear
- 3. Limitation on the Number of Gillnets that May be Hauled on Georges Bank when Fishing Under a Groundfish/Monkfish Days-at-Sea (DAS)
- 4. Limitation on the Number of Gillnets for Day Gillnet Vessels
- 5. 20-Day Spawning Block
- 6. Limitation on the Number of Hooks that May be Fished
- 7. Length and Horsepower Restrictions of the DAS Leasing Program
- 8. Gulf of Maine (GOM) Sink Gillnet Mesh Exemption
- 9. GOM Sink Gillnet Mesh Exemption in May
- 10. Dockside Monitoring (DSM) requirements for Vessels Fishing West of 72°30' W. long.
- 11. DSM Requirements for Vessels Fishing on Both a Monkfish and Multispecies DAS in the Southern Fishery Management Area using 10-inch or Greater Mesh
