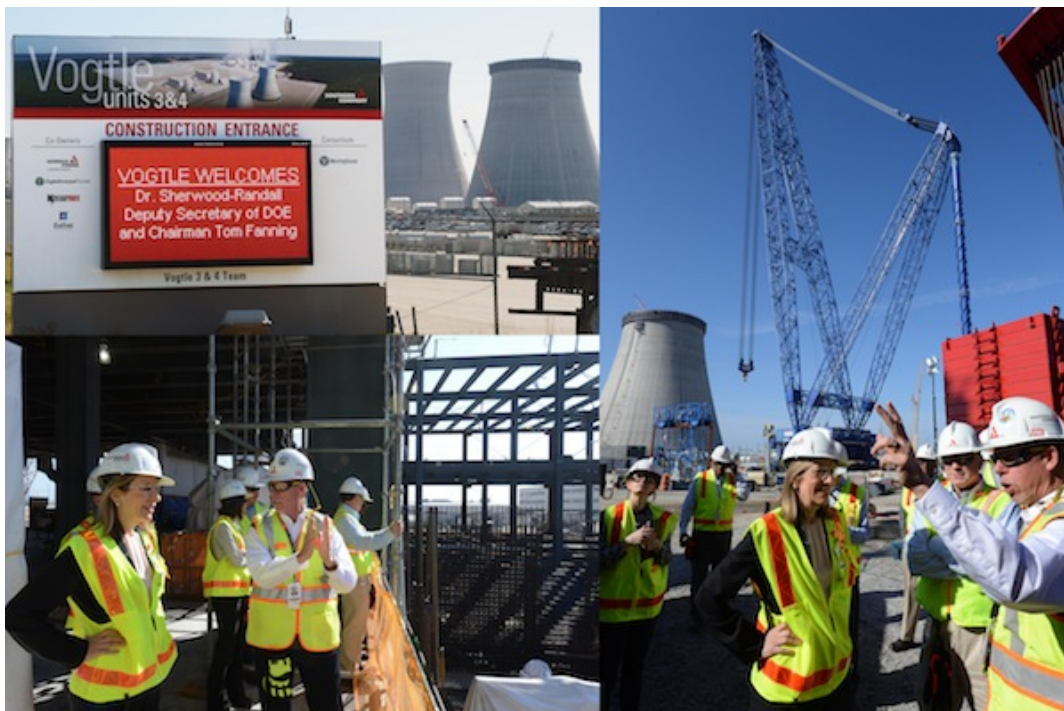

Plant Vogtle in Waynesboro, Georgia early last month, viewing progress on the nation's first new nuclear reactor construction in 30 years. Upon completion, Vogtle Units 3 & 4 are expected to generate 17,200,000 megawatt-hours of clean energy and prevent 10 million metric tons of carbon dioxide emissions annually. 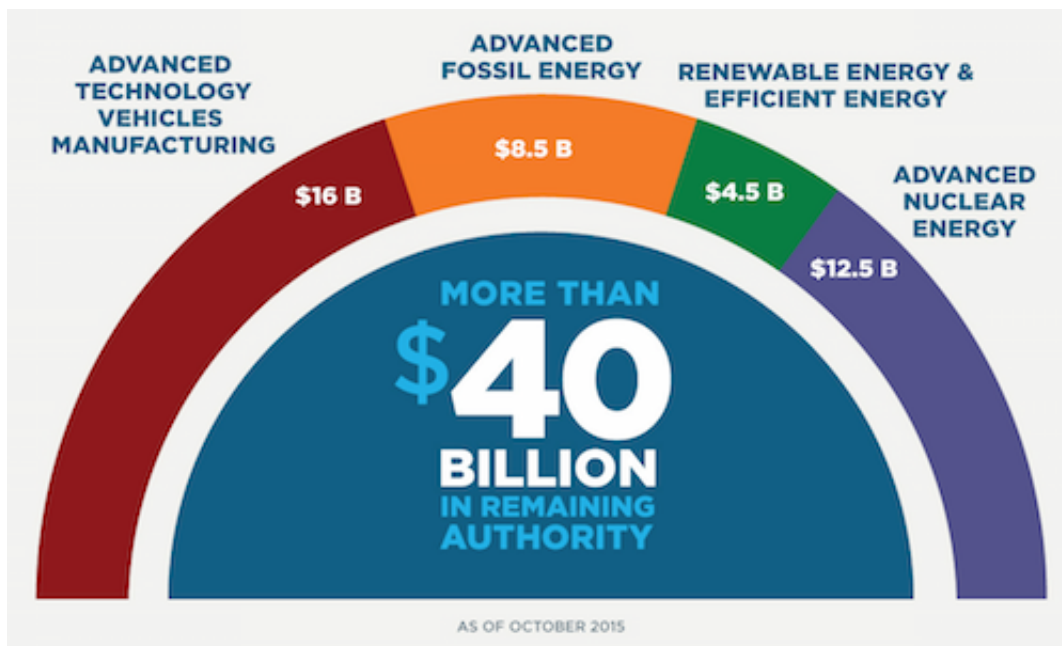
LPO NAMES ALEX MISHKIN NEW DEPUTY EXECUTIVE DIRECTOR
