A Federal government-wide ordering agreement with Onix Networking Corporation has been established for software, training and maintenance on behalf of General Services Administration (GSA) SmartBUY. This contract reduces contracting and open market costs, such as search for sources, the development of technical documents, solicitations and the evaluation of bids and offers. This Blanket Purchase Agreement (BPA) will further decrease costs, reduce paperwork and save time by eliminating the need for repetitive, individual purchases from the schedule contract. The objective is to create a purchasing mechanism for the government that works better and costs less.

This BPA has been designated as a co-branded GSA/Federal Acquisition Service (FAS)/SmartBUY Program Management Office (PMO) and Department of Defense (DoD)/Enterprise Software Initiative (ESI) Agreement, which is open to all U.S. Executive Agencies (as defined in 48 CFR 21), including the DoD, authorized state and local government entities and authorized contractors, except as restricted herein.
